2020 AAUW Pennsylvania State Convention

This weekend, we would have been gathered in Harrisburg. Originally scheduled for April 24-26, in mid-March, the convention was postponed to July 13-15. At the time of that decision, there was little known about the coronavirus and duration of the pandemic, so it seemed July was realistic.

Current knowledge indicates that a gathering of 113 (number of registrants for April) cannot safely occur in July. At the April 18 AAUW Pennsylvania Board meeting, we voted to cancel the 2020 AAUW Pennsylvania State Convention. At least the face-to-face part. How to Frame the “celebration” of the 100th anniversary of the 19th amendment

In our local celebration events, it is important we follow AAUW's lead on how to recognize this anniversary. These are the first thoughts about recognizing the 100th anniversary of the 19th amendment as shared in the December 5th and January 28th [webinars](#).

- AAUW recognizes the struggle to pass the 19th Amendment in 1920, and that it wasn't until 45 years later, when the Voting Rights Act of 1965 was passed that women of color were granted the right to vote.
- Today, there are still challenges with voter access and voting suppression which is why AAUW will focus on ensuring every vote is recognized in 2020.
- States and branches should acknowledge the importance of the 100th anniversary while also educating members and the public on why the anniversary does not encompass all women's right to vote.
- We have to keep up the fight -- as the country still struggles with voter access and voter suppression.

National Conference for College Women Student Leaders (NCCWSL)

As a result of the ongoing concerns regarding COVID-19 and the impact from travel restrictions and need for physical distancing, NCCWSL 2020 that was scheduled to take place May 27-30, 2020, at the University of Maryland, College Park has been postponed. This heartbreaking decision is responsive to the advice of health authorities and the World Health Organization (WHO) who have declared a global pandemic. AAUW's first priority is the health and welfare of our dedicated staff, NCCWSL participants and the campus community.

AAUW National provided two options for the NCCWSL 2020 Registration Fee to be refunded or to apply funds to transfer to NCCWSL 2021, which will be held at the University of Maryland, College Park, on May 26-29, 2021. We had 8 funded grants provided by; Pittsburgh Branch 1, Carlisle Branch 1, Bethlehem Branch 2, and AAUW-PA 4. Each funding branch along with the PA Board agreed to transfer the grant funds to 2021. Additionally the student recipients have been notified that their grant will be transferred and available to them provided that they are enrolled as an undergraduate or graduate student in 2021. The students while disappointed understood and are grateful that they can have their grants transferred to NCCWSL 2021. I will be sending them a registration form to update and confirm their availability in the January/February 2021 timeframe.

If your Branch registered a student, the person who completed the registration from the branch would have been notified of these changes and given direction on how and who to move forward with requesting a refund or how to process a transfer to NCCWSL 2021. Membership Reminders

AAUW membership renewal season has begun. If your branch affiliate participates in the Membership Payment Program (MPP), notices were sent to each of your members on April 20th. The subject line reads: AAUW Membership Renewal for Fiscal Year 2021 followed by the member's number. For MPP participants, the member still can renew in two ways: 1. By clicking on the link and renewing by credit card or 2. By mailing a check (made payable to the branch affiliate) to the Finance Officer. The member pays all three AAUW dues – national (\$59), state (\$10) and local affiliate dues at once.

April and May always have been the best times to ask your members to renew. Many of you offer renewal incentives for members renewing by a certain date, such as a drawing for a free membership. Because we are meeting virtually, your renewal efforts will be handled via email, newsletter, telephone calls and sometimes snail mail. Keeping members informed gives value to their AAUW membership. No it does not replace actual meetings, dinners or events, but communication lets your members know that you care about them.

A word about the MSD (Membership Services Database). On March 19, 2020 you received the AAUW February Branch Membership Count for Fiscal Year 2020 (which ends on June 30, 2020). Discrepancies in the count were to be reported to connect@aauw.org by April 3. If you still have an unreported discrepancy, I suggest that either your Membership VP or Finance Officer contact Connect asap. If you need any help in resolving your member count, please email me at aauwmembership@gmail.com. AAUW launched its new website on April 6th. The easiest way to access the MSD is to click on the membership tab at the top of the home page. Once in the membership section, there is a place to click on the MSD. After signing in to the MSD, you can access your branch affiliate information.

Please make sure the email addresses for your members are accurate in the MSD.

Another culprit might be the SPAM filter on .edu email addresses. Please advise members with .edu addresses to add aauwpainfo@gmail.com to the approved sender list.
