Sending along a few more updates. This is usually the time of year when branches are looking forward to end of the year banquets Unfortunately, those events will probably not happen in the near future. However, one major event is coming. That is the

Pennsylvania primary on June 2.

While some parts of the state may be open by then, other areas like the southeast may still be shut down. No matter where you live, you may still have concerns about going to the polls. We also will be using new voting machines, which may slow down voting since people are not familiar with them. However, there is a solution.

Vote by mail.

With the changes to the Pennsylvania voting law last fall, you no longer need an excuse. Apply now at VotesPA.com/MailBallot. Be sure to select the Mail in Ballot and not the Absentee Ballot. You can also check your registration status while you are on the site.

Since the date of the primary has been moved all other deadlines have also been moved. New dates are:

May 18: Last day to update your voter registration

May 26: Last day to apply for a mail-in-ballot

June 2, 8pm: Deadline to return your voted mail-in-ballot

If you enter your email address when you apply, you will receive updates on your ballot status.

Preparing for the Election

AAUW is already at work on materials you can use to educate your members and the community about the election issues. The 2020 Voter Issue Guide is now available. It provides nonpartisan information about the policy concerns that are critical to women and their families.

Take it to virtual town halls and candidate forums to follow along with the debate. This issue is part of the AAUW Gender Agenda for 2020.

Implement Paid Leave and Paid Sick Days.

Unlike the majority of developed countries worldwide, the U.S. does not guarantee paid time off for illness, family care or parental leave.

- Federal: pass the Family and Medical Insurance Leave (FAMILY) Act and the Healthy Families Act.
- **Pennsylvania:** pass the Family Care Act paid leave insurance program, HB1739 and SB580 which have bipartisan support in both the house and senate.

The nation's lack of paid sick and family leave is endangering both the physical and economic wellbeing of countless American families.

The Bucks County Women's Advocacy Coalition (BCWAC) is hosting this webinar on paid leave. Included in the excellent lineup of panelists is the Family Care Act campaign's Marianne Bellesorte from Pathways PA, an AAUW-PA Gateway to Equity Award winner. The event will also feature messages from Family Care Act sponsors, Rep. Wendi Thomas, (R-178). and Sen. Maria Collett (D-12). This legislation is truly bi-partisan. If nothing else, COVID-19 has shed light on the systemic economic issues facing families. A flyer with more details is attached.

This is a great opportunity to learn about this issue and what we can do about it in Pennsylvania.
