#### Two changes must be on your radar during FY21

#### **Dues Increase**

Every AAUW member received an email, on October 30<sup>th</sup>, from Julia Brown, AAUW Board Chair, announcing an increase Individual Member dues for the next three years. The dues will rise by \$3 for Fiscal Year (FY) 2022, \$5 for FY 2023 and \$5 for FY 2024, making the total dues amount for those years \$62, \$67 and \$72, respectively. This topic is covered more extensively in the December Keystoner.

#### **Membership Education Requirement**

Proposed change to AAUW bylaws to remove the education requirement for membership will be in the AAUW national election this in Spring 2021.

Since the Kim Churches' very candid discussion on December 5, 2019, the need for this change has been shared with members. And, Kim even discussed with us in her April 2018 state convention keynote address. More information will be forthcoming as part of the AAUW national election process.

# **Public Policy UPDATE**

#### Pay Equity

The new pay equity numbers by congressional district were included in the October Issue of Highlights which was sent to all branch public policy chairs and branch presidents. In general salaries increased. The median earnings for men in Pennsylvania increased 4%, while women's median earnings only increased 1%. Income in Pennsylvania did not increase as much as in other states or for women compared to men, which means we fell from an earnings ratio of 81% or 21<sup>st</sup> out of all the states last year to 79% or 32<sup>nd</sup> out of all the states this year. View the charts for the 2019 Pay Gap and the 2020 Pay Gap to see where your congressional district stands. The numbers are based on all women and are from the U.S. Census Bureau, American Community Survey, 2019 which does not include data from this spring's Covid-19 impact on wages. The numbers are not broken down by race or ethnicity, but we know that the ratios for women of color are much worse.

In all fundraising efforts, the branch must be absolutely transparent and spell out what the donations are going towards. The language should be as ironclad as possible so that a donor doesn't stumble onto the branch website, make a gift, and expect that it went to the national office etc. As long as you are very clear that the donation will be used for a specific branch purpose of the branch and that the donation is or is not tax-deductible based on the tax status of the branch, then there should not be any overt conflicts.

The Student Impact Mini-Grant application original deadline of October 30, 2020 is being extended until February 19, 2021 and will be awarded on a first come, first serve bases. Applications will be reviewed on an ongoing basis. The grant application selected will be eligible to receive a grant of up to \$200. #### 2021 National Conference for College Women Student Leaders (NCCWSL) May 26 – May 29, 2021

Please remember that the May 2020 NCCWSL was postponed to 2021 due to COVID-19. This resulted in the funds for the 2020 award year being transferred to NCCWSL 2021. The 2020 eight awarded and funded grants are from Pittsburgh Branch 1, Carlisle Branch 1, Bethlehem 2, and AAUW-PA 4. In June 2020, all of the eight awarded students accepted the grant transfer to attend the May 2021 NCCWCL. The waitlisted students were also notified of this update. The next step is for me to confirm that these students are still enrolled and able to attend the May 2021 NCCWSL.

Additionally AAUW-PA will be awarding four new NCCWSL grants for 2021. As a way to add more grants, AAUW-PA is offering the option for branches to support NCCWSL grant recipients through donations to the state. You can send your funds to AAUW-PA in increments of \$500 and the state will use these funds to support a Pennsylvania student through our application process.

If you choose this option, your branch will not get credit as a branch from national for a donation to NCCWSL, as the funds will go from the state to the student directly and not through national AAUW. Funds need to be received by the state no later than February 23, 2021.

Branches may also individually provide a Branch NCCWSL grant. If your branch does this please report it to state C/U Liaison Peggy Schmiedecke <u>aauwpacu@gmail.com</u> for record keeping purposes.


