Nominees for State Board Positions

The AAUW PA Nominating and Elections committee is pleased to announce a full slate of nominees for the upcoming elections. Astute readers will notice that Cynthia Hall has agreed to run for President rather than for, as previously announced, Program Vice President.

PRESIDENT:

Cynthia Hall, State College Branch

Cindy is currently the Co-Vice President for Marketing and Communication for her branch, having previously served on the Education subcommittee, as Co-Vice President for Membership (2016-17), as Co-President (2017-21), and as immediate past President the following year. In 2017, she was awarded the Member Making a Difference Award and, in 2021, the Outstanding Woman Award, both from State College Branch.



Cindy has attended a state summer retreat, Central District meetings, and two state conventions. She was an alternate for the National Nominating Committee in 2020-21 and is serving on that committee currently.

Cindy retired from her job as Associate Vice President for Strategic Communications and Chief Marketing Officer from Penn State University in 2015. She also taught Public Relations Media and Methods and Public Relations Campaigns as a part-time instructor in the College of Communications at Penn State. She has significant experience in branding, marketing research, communications, and management. In addition, she managed major political candidate visits for Penn State (Barack Obama, Hillary Clinton).

Cindy holds a Ph.D. from Penn State and graduated from the in-residence Management Development Program (MDP), Harvard University Graduate School of Education. She has received more than 20 awards from CASE (Council for Advancement and Support of Education), and was selected as one of 25 women nationally to participate in the CASE Forum for Women Institutional Advancement Officers. Cindy participated in a roundtable for Trustee Magazine on Branding, Chicago as well as for PR Week, New York. She has been conference chair for several CASE conferences and a frequent speaker. In addition, Pennsylvania Business Central named Cindy as one of the Top 20 Nonprofit Female Leaders in 2019.

Cindy presented her research titled Gendered Roles/Gendered Relations: A case study of the status and role of women in a research university at AERA (American Educational Research Association), San Francisco.

When asked what she sees as the primary focus of AAUW-PA and how she would work toward that goal if elected, Cindy answered:

"Helping to achieve a clear and consistent vision for AAUW by coordinating and communicating effectively with both the state's branches and national is a priority for AAUW PA. For the organization to remain strong in a highly turbulent environment, AAUW must be differentiated from the increasing numbers of organizations beginning to share the same space.

The AAUW PA President, working closely with state and branch leaders, must ensure AAUW's mission is both understood as well as acknowledged and respected across the state. We must continue to advocate for increased understanding as to how our mission is vital to the success and advancement of the Commonwealth.

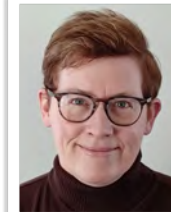
The past few years presented major membership and financial challenges for many branches. We need to rebuild any ground that has been lost due to diminished in-person interactions and activities. We should remind ourselves of the critical role we play in achieving our mission-specific goals. The President and all leaders must reinvigorate members to address these challenges and invite others to join us in our mission."

PROGRAM VICE PRESIDENT:

Lori Woods, Indiana County Branch

Lori is currently Public Policy Chair and University Liaison for her branch, having previously served as Program Vice President (2017-19). In 2017, she was awarded the Member Making a Difference Award. As Program VP, she organized a panel discussion on women's health needs in rural areas, chaired an economic forum that aimed to hear from women civic leaders and candidates running for office about how the County might improve the economic status of women and their families, and participated in Start Smart workshops. More recently, she assisted with her branch's planning of the 100th Anniversary of Women's Suffrage in Indiana County, and teamed up with the Alice Paul House for Sexual Assault Awareness Month.

A strong advocate of interdisciplinary education, Lori serves as the Associate Dean of the School of STEAM (Science, Technology, Arts and Mathematics) at Saint Francis University (Loretto PA). She has taught the history of medicine and science, and women and gender history for thirteen years. She has also served as National Secretary of the Association of General and Liberal Studies (AGLS) and as Branch Secretary of the NAACP in Indiana County, PA.



Lori has advocated for women in STEM fields, mentoring girls in her community through her volunteer work with the local NAACP. In her teaching, she emphasizes the unique lives and experiences of women in the past, seeking to instill life-long learning in her undergraduate students. Lori has published in the field of women and gender history, having worked with pioneers such as Natalie Zemon Davis, a recipient of the National Humanities Medal.

When asked what she sees as the primary focus of AAUW PA and how she would work toward that goal if elected, Lori answered:

"The primary focus of AAUW PA is to be a strong advocate for effective public policy that supports women and families throughout the commonwealth. In my view, one of the challenges is to find ways to motivate the next generation to get involved. This requires reaching out to the community at large, meeting people where they are, including those whose voices are often not heard.

I will use my knowledge and experience as a teacher, as well as my involvement in the leadership of organizations that work to effect good, strong public policy, in order to develop a robust program that will motivate an audience who is moved to get involved in the mission of AAUW, ultimately to build coalitions to help address the gaps in public policy."

AAUW PA 2022 Election Voting Instructions

NOTE: This year there will be NO in-person (or synchronous on Zoom) voting during the annual meeting. Please vote by April 13! Candidate information found on page 2.

OPTION 1: ONLINE VOTING

- * Click on the link <https://www.surveymonkey.com/r/AAUWPAElections2022> OR copy and paste this link into your browser.
- * Online voting is available now through 11:59 pm, April 13, 2022.
- * Clicking this link will bring up the nominees' bios. The "next" button at the bottom of the page sends you to instructions and three boxes asking for voting confirmation information: 1) first name; 2) last name; and 3) AAUW affiliation: branch name, C/U rep, or national membership. This information will not be connected to your vote. Voter names and AAUW affiliation are required only to verify that you are a current paid AAUW PA member and that you are not voting multiple times.
- * Clicking the "next" box on that screen will bring up the actual ballot: candidate names for the nominees for Membership Vice President, Secretary, and Finance Officer along with an option for each office for a write-in candidate.
- * Be sure to hit "Done" at the end to record your votes.
- * Branches may facilitate online voting at a branch meeting.

OPTION 2: PAPER BALLOT VOTING

- * Clip out and return the official ballot. 
- * Return your completed ballot to your branch president or to the Nominations and Elections Committee chair by mail. To be valid and counted, mail-in ballots must be postmarked **no later than April 13, 2022**, and sent to Deb Roney AAUW PA Nominations, 11078 Carriage Hill Rd., Huntingdon, PA 16652.
- * Voting instructions must be completed exactly as required in order for your ballot to be valid. If you have any questions or concerns about the appropriate way to file your ballot, please ask for clarification from your branch officers or from AAUW PA officers before voting.
- * Mark an "X" in the blank provided on the ballot for each candidate. You may write in a candidate (on the line after "Other") and vote for that person (by marking an "X" in the blank before "Other").
- * In the box on the side of the ballot, PRINT legibly your name as it appears in AAUW membership records and branch affiliation (if you are not a member of any particular branch, PRINT "National and State Member" or other appropriate affiliation).
- * SIGN the ballot where indicated in the box.
- * FOLD your ballot on the dotted line so that the box with your information is folded away from your casted votes. Once your membership has been validated, the identification information in the box will be cut off from your cast votes, and your votes will then be included with the other mail-in ballots, mixed up, and counted.
- * FILE your ballot either by returning it to your branch president to bulk mail or by mailing it yourself.
- * The ballot must be postmarked by April 13, 2022.

OPTION 3: VOTING THROUGH YOUR BRANCH

Branches may choose to hold a vote at the branch level. Your branch President/Administrator(s) received instructions about this option; check with branch leadership to see if this option will be available. If not, please vote using Option 1 or Option 2 above.

- ☑ Bid early; bid often.
- ☑ Bidding on silent auction items at convention will be open from the opening of registration on Friday through Saturday dinner. Visit the basket display to place your bids.

- ☑ The person with the highest bid on each basket and online item wins! Winners will be announced at the awards session at convention on Saturday night, June 4.
- ☑ You do not need to be present to win.

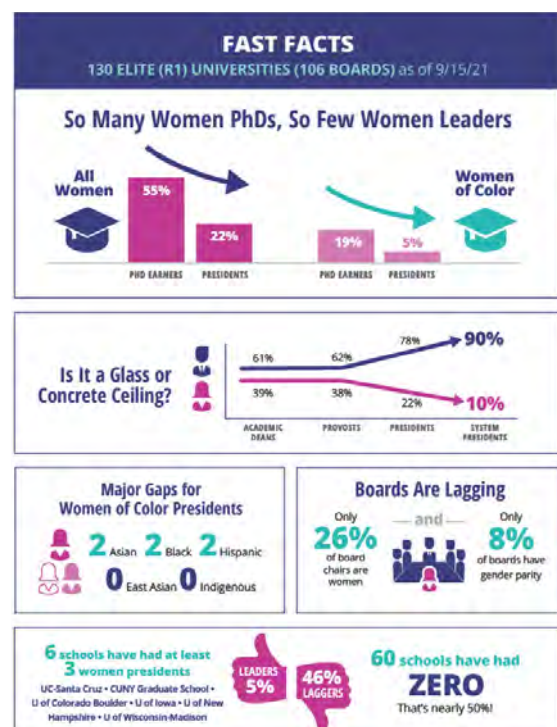

Proposed Bylaws Changes

The Nominating and Elections Committee proposes the two bylaws amendments below for your consideration and vote by the membership at the annual meeting on April 23, 2022.

CURRENT WORDING:

ARTICLE XI. AFFILIATE OFFICERS

Section 1. Affiliate Officers

e. No elected officer shall hold more than one office at a time, and no officer shall be eligible to serve more than two consecutive terms in the same office. No officer with the exception of the president shall be eligible to serve on the board for more than eight consecutive years.

PROPOSED NEW WORDING (additions underlined):

ARTICLE XI. AFFILIATE OFFICERS

Section 1. Affiliate Officers

e. No elected officer shall hold more than one office at a time, and no officer except the administrative director shall be eligible to serve more than two consecutive terms in the same office. No officer with the exception of the president and the administrative director shall be eligible to serve on the board for more than eight consecutive years.

RATIONALE:

These changes will:

- facilitate the effective running of the organization.
- recognize that the administrative director has a fundamentally different role in the organization than the elected and appointed officers have.
- not compromise the existing, valuable goal of having a board of directors with diverse backgrounds bringing new perspectives to the organization, as all other elected and appointed officers except the president will still have the existing term limits.
- not require that the administrative director continue for several terms but would allow for it. Any president could appoint a new person at any time.
- bring AAUW PA into compliance with current practice. [Through a series of presidential appointments, Pat Byerly has held this role since 2012.]

Proposed Public Policy Priorities 2022-2024

AAUW PA's public policy goals are to educate citizens about the impact of public policies on women and girls and to advocate for policies that will advance equity for women and girls. In Pennsylvania, AAUW actively endorses the national [AAUW Public Policy Program](#). AAUW Pennsylvania supports good governance, an informed citizenry, and community dialogue on critical issues. Biennial priorities are intended to complement national priorities and to be a focus for active educational and advocacy efforts by members in the state.

To enable members and all citizens to participate fully in a representative democracy and self-governance, AAUW PA advocates

- Awareness of issues so that members may be fully informed and empowered voters
- Opposition to measures likely to suppress voting rights
- Support for efforts to increase civil discourse and compromise between those with opposing views
- Efforts to Get Out the Vote, including voter registration and use of social media to promote voting

To support a quality system of public education, AAUW PA advocates

- Opposition to the diversion of public funds to non-public elementary and secondary education, charter and cyber charter schools
- Support for a fair and adequately funded system of public education
- Strengthening secondary and post-secondary programs that provide women with education, vocational training, and support for success in the workforce, including non-traditional occupations
- Policies promoting inclusion, diversity, equity and justice in our schools

To improve the economic self-sufficiency of all women, AAUW PA advocates

- Pay equity and fairness in compensation and benefits
- Raising the minimum wage and tipped minimum wage to an amount that would provide a meaningful boost to family incomes in Pennsylvania and help grow the state's economy
- Vigorous enforcement of employment anti-discrimination statutes
- Creating family-friendly workplace environments, including flexible workplace policies, paid leave for personal and family illness, and quality child-care facilities available to all parents regardless of their circumstances
- Improving retirement security
- Reducing the unprecedented level of student debt and the record high cost of college

To improve the operation and transparency of government, AAUW PA advocates

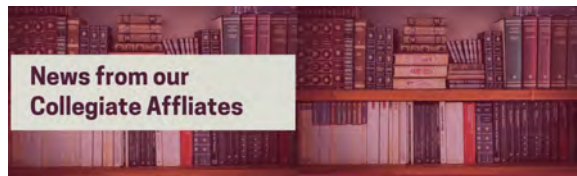
- Measures to improve the efficiency and effectiveness of government that can improve the well-being of women
- Efforts to end the practice of partisan redistricting, gerrymandering in Pennsylvania



School Funding Lawsuit

The lawsuit filed in 2014 to challenge the constitutionality of Pennsylvania's state budget funding process is finally being heard in Commonwealth Court in Harrisburg. Applications for AAUW PA NCCWSL grants to pay registration fees for attendees to the National Conference for College Women Student Leaders (NCCWSL) are due March 31, 2022. AAUW PA will be funding up to 12 NCCWSL registration grants to PA female-identifying undergrad or graduate students. For info and the AAUW PA grant application, go to

While our grant registration is almost closed, NCCWSL regular registration is still open. If we still have AAUW PA NCCWSL Grants available, we will extend the grant application deadline.

I will be handling NCCWSL registrations for our grant recipients. Students should not register themselves. For information on AAUW's premier leadership conference for young female-identifying women, go to www.NCCWSL.org. This year's conference will feature a special half-day session on "Design Thinking" that students will not want to miss!

Branches may send NCCWSL grant donations to the state. You can send your funds to AAUW PA in increments of \$225 and the state will use these funds to support a Pennsylvania student through our application process. If you choose this option, your branch will not get credit as a branch from national. These branch donations for NCCWSL will go from the state to the student directly and not through national AAUW. Funds need to be received by the state no later than March 20, 2022. Branches may also individually provide a branch NCCWSL grant. If your branch does this, please report it to state C/U Liaison Peggy Schmiedecke, aaupacu@gmail.com for record purposes.

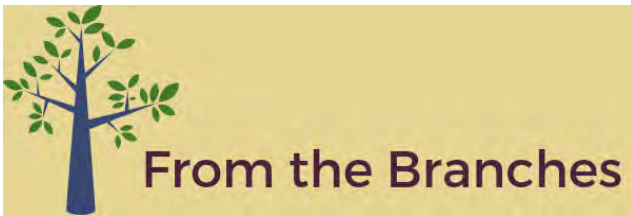

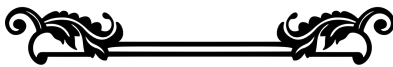
Time to Visit and Shop

Pittsburgh Justice Summit

In January, North Hills Pittsburgh was a supporting organization for the 24th Annual Pittsburgh Justice Summit (PJS). The PJS was a one-and-a-half-day conference dedicated to providing resources and spaces for community dialogues, sharing strategies and experiences of organizing for racial justice, healing from racial trauma, and providing connections to social support services for all attendees.



The summit included multiple sessions and addressed the topic of Intersections of Racial and Gender Justice in Public Policy. "Racial justice intersects with gender justice, impacting all aspects of daily life such as housing, health, education, safety, etc.," said Anupama Jain, inaugural executive director for the City of Pittsburgh Gender Equity Commission who facilitated the session. "However, public policies have claimed to be 'colorblind' or 'gender neutral,' and often most benefited those with existing social privileges."

During the discussion about the 2018 case study report *Pittsburgh's Inequality Across Race and Gender* by the Gender Equity Commission, we discussed the importance of learning to successfully advocate for ourselves, and helping close the pay gap for women everywhere. As you seek things to fill your time as you stay at home, cleaning closets and files, you may find AAUW material that is no longer needed. I am still collecting and sorting files for their eventual home in the State Archives, although I keep at least 10 years of files at hand.

Going forward, one of the most important tasks is to contact past and current board members as well as former members and officers to determine if they have any records. Many important records are lost through failure or neglecting to pass on; illness or death of a member with archive material could mean they are lost forever. Their families are unaware of their importance.

Yearbooks should contain current membership and branch board members, committee chairs, past presidents, all past award recipients (Outstanding Woman, TEAL award, Emerging Star and Spotlight, Gateway to Equity awardees, honorary life members and life members and a listing of programs. If your branch does not compile a yearbook, a single document will suffice.

Your branch newsletter should highlight awards received from the state, negating the need for retaining award certificates. You may however want to keep a folder of these certificates.

News articles are best kept if photocopied when they are new. Copying news articles prevents newsprint from aging.

Keep these guidelines in mind:

DO

- Put date and name on every document.
- Label photos with event, names and date.
- Minimum to retain at least 10 years of the following at Branch level, anything older may be archived:
- Newsletters, Yearbooks, Agendas, Minutes, Financial reports, Chair and committee reports, Bylaws, Special projects, and Anniversary material.
- I recommend keeping all anniversary documents and displays at Branch level.

DON'T

- Place material in scrapbooks, plastic sleeves or notebooks (use file folders or hanging files and store in plastic file boxes).
- Retain state or national material; it is already archived (I will be happy to accept these items as we may not have them at state level.)
- Do not use metal paperclips or non-rust resistant staples; discs or sticks.
- News articles that duplicate newsletter or yearbook.
- Articles or items not germane to AAUW; obits, etc.

As always, I am available to assist in any way to help your branch and I can visit your branch if requested. You can call or email anytime. I am still available to travel to your branch for pick-up and will practice safe distancing and pick up from your driveway.
