

The trial is expected to last well into February. Fund Our Schools has fabulous <u>updates and summaries</u>. Children First and Education Voters PA are organizing events in Harrisburg and in communities across the state to follow the trial and show support for school funding that provides for quality public education, regardless of local wealth. Go to their advocacy website—<u>Thorough and Efficient</u>-- for information. AAUW branches have been advocating for fair funding for years! This case is a major milestone in that advocacy.





Proposed AAUW Pennsylvania Bylaw Amendments

The Nominating and Elections Committee proposes the two bylaws amendments below for your consideration and vote by the membership at the annual meeting on April 23, 2022. The original text can be found on p. 6 of the <u>current</u> bylaws.

CURRENT WORDING

ARTICLE XI. AFFILIATE OFFICERS

Section 1. Affiliate Officers

e. No elected officer shall hold more than one office at a time, and no officer shall be eligible to serve more than two consecutive terms in the same office. No officer with the exception of the president shall be eligible to serve on the board for more than eight consecutive years.

PROPOSED NEW WORDING (additions in bold):

ARTICLE XI. AFFILIATE OFFICERS

Section 1. Affiliate Officers

e. No elected officer shall hold more than one office at a time, and no officer **except the administrative director** shall be eligible to serve more than two consecutive terms in the same office. No officer with the exception of the president **and the administrative director** shall be eligible to serve on the board for more than eight consecutive years.

RATIONALE

These changes will:

- facilitate the effective running of the organization.
- recognize that the administrative director has a fundamentally different role in the organization than the elected and appointed officers have.
- not compromise the existing, valuable goal of having a board of directors with diverse backgrounds bringing new
 perspectives to the organization, as all other elected and appointed officers except the president will still have the
 existing term limits.
- not require that the administrative director continue for several terms but would allow for it. Any president could appoint a new person at any time.
- bring AAUW PA into compliance with current practice. [Through a series of presidential appointments, Pat Byerly has held this role since 2012.]

Two of AAUW Pennsylvania's coalition partners are holding a <u>Facebook Live</u> event on Friday, February 25 from 11:30 am to 1:00pm.

PA Commission for Women is hosting and PA Coalition Against Domestic Violence (PCADV) will talk about economic abuse and pay equity. Additional agencies will share existing economic resources for survivors.

A Major Title IX Ruling with Pennsylvania Origins

Do you remember the 2015 murder of a student by her abuser, who wasn't a student, in her Millersville University (Millersville, PA) dorm room? The family's Title IX claim was denied because the abuser was not affiliated with the University. Another AAUW Pennsylvania partner, The Women's Law Project, filed a friend of the court brief in the appeal to the Third Circuit, arguing that dating violence is a form of sex-based harassment that, under Title IX, the school had a legal responsibility to address.



In mid-January, the U.S. Court of Appeals for the Third Circuit issued a ruling confirming that <u>Millersville University can be held liable</u> <u>under Title IX for failing to protect Karlie Hall</u>. This decision recognizes and affirms critical Title IX sex discrimination protections for victims of stalking and sexual, domestic, and dating violence. It is now clear: If a school is aware that one of its students faces serious, ongoing sex-based discrimination, harassment, or violence and if the school has the power to act, the school cannot fail to respond just because the danger is posed by a person who is an unaffiliated third-party.

AAUW Pennsylvania is proud to offer opportunities for leadership development for university and college women in Pennsylvania through grants to attend the National Conference for College Women Student Leaders (<u>NCCWSL</u>). This is a wonderful opportunity for hundreds of college women to gather for three days of leadership training, inspiration and networking. Participants enter the conference as a passionate leader and leave it with the skills and confidence to pursue their goals.

The 2022 virtual conference schedule, agenda, early bird pricing and other information will be updated regularly <u>here</u>, so check back often. Also, this year's conference will feature a special half-day session on "Design Thinking".

Applications for AAUW PA grants to fund registration fee for a student to attend the NCCWSL will be available at <u>AAUW</u> <u>Colleges/Universities/Students | Pennsylvania</u> in early February. The grant application submission deadline is March 31, 2022. AAUW PA will be funding up to 13 NCCWSL Registration Fee Grants to PA female identifying undergraduate or graduate students.

Branches may send NCCWSL grant donations to the state. You can send your funds to AAUW-PA in increments of \$150 and the state will use these funds to support a Pennsylvania student through our application process. If you choose this option, your branch will not get credit as a branch from national. These branch donations for NCCWSL, will go from the state to the student directly and not through national AAUW. Funds need to be received by the state no later than March 20, 2022. Branches may also individually provide a Branch NCCWSL grant. If your branch does this, please report it to state C/U Liaison Peggy Schmiedecke, auwpacu@gmail.com for record keeping purposes.

Student Impact Mini-Grant

The inaugural year (2021-2022) of the Student Impact Mini-Grant program was very successful. We awarded two grants to undergraduate students to start or continue an advocacy project locally. See page 7 of <u>November FYI</u> for details. Building in this success, AAUW Pennsylvania is happy to be able to continue the Student Mini-Grant Program for this fiscal year. As you work with students in your community, please share information about these grants.

The Impact Mini-Grant application deadline has been extended to February 28, 2022. It will be awarded on a first come, first serve bases. Applications will be reviewed on an ongoing basis. The grant applications selected will be eligible to receive a grant ranging from \$100 to \$300. Go to <u>AAUW Colleges/Universities/Students | Pennsylvania</u> for information, ideas, resources and the application. Also, an AAUW-PA Impact Mini-Grant Activity Report-Back Form (will be provided to awardees to return within 30 days of event/program which must take place by or before June 15, 2022). At this time no applications have been submitted, if you are aware of a student project that could use funds, please share this information with them.


