PUBLIC POLICY UPDATES



We have been closely watching Harrisburg's activities that have impacted our priorities since the election. With so much uncertainty about the leadership in the House of Representatives (<u>The fight over control of the Pa. House is Harrisburg high-stakes lunacy at its worst - Pennsylvania Capital-Star (penncapital-star.com)</u> it is unknown what will happen in January. This uncertainty concerns us as the previous House Leadership intended to run the Constitutional Amendments that include reproductive rights, voter rights, and regulatory restrictions. These

amendments must be passed a second time in the upcoming new session in order for these proposals to be placed on the ballot as referendums. With early passage, these amendments could be on the Primary ballot in May. Control of the house will dictate the agenda for January and we are monitoring the situation carefully. We are part of coalitions working on many fronts and we will keep you posted as things in Harrisburg become clearer.

In principle and in practice, AAUW values and seeks an inclusive membership, workforce, leadership team, and board of directors. There shall be no barriers to full participation in this organization on the basis of age, disability, ethnicity, gender, gender identity, geographical location, national origin, race, religious beliefs, sexual orientation, and socioeconomic status.

On **January 3rd**, a rally was organized by **Fix Harrisburg** on the Capitol steps. Several interested members of AAUW were there and we had signs with our AAUW logo ready! These efforts are to change the rules that govern the actions of our representatives—from how a bill is moved through committees and who controls the voting procedures. AAUW formally joined as a supporting organization in November 2022 and we endorse their efforts to **Fix Harrisburg**! <u>FixHarrisburg</u> | <u>Reform the Rules</u> | <u>Pennsylvania</u> | <u>#Fix Harrisburg</u>. This



coalition was founded by Fair Districts PA and the League of Women Voters. It is important to note that new maps which resulted from Fair District PA's effort resulted in more opportunity districts throughout the state and more representatives reflective of their communities' constituents.

We are patiently waiting to hear from the Commonwealth Court judge about the **School Funding Lawsuit** (**FundOurSchoolsPA.org**). This decision could come any day and we hope to have members participate in actions around the state to support our schools' need for adequate and equitable funding! Education Voters is organizing advocates and if you are interested, please complete this form in order to be notified after the decision. <u>Yes! Please send me information about being part of a response when the decision in PA's school funding lawsuit is issued.</u> (google.com)

In other education news, several of our members are assisting advocates in fighting against book bans and harmful policies that affect some of our most vulnerable students. We hope to support these efforts and more information will be included next month about a statewide coalition working with parents and organizations from around the Commonwealth. In the meantime, please reach out to me at smiller2043@gmail.com if you are interested in resources and information about these efforts.

On the federal side, we were thrilled to see the signing of the **Respect for Marriage Act** in December. In addition, AAUW staff have been advocating for the passage of the **Pregnant Workers Fairness Act** and we hope that when you are reading this update, it has been passed by the Senate and sent to the President's desk. December 2022 marked the end of this legislative session and all legislation not passed and sent to the President's desk will need to be re-introduced in the upcoming session starting January 2023.

We had a very interesting discussion regarding the **Equal Rights Amendment** and the work going on by the Equal Rights Amendment Coalition in Washington DC by one of our own, AJ Conroy. If you are interested in the material that was shared, please reach out to me. It was a closed meeting but I will try to link you or our members to the activists working on this important issue.

We had hoped to share the 2023 Equal Pay Days in this edition, but we have not received this information yet. Barb Price is monitoring the national scene as the chair of the AAUW Public Policy Committee and we will share all information as soon as we have it!

One final note on an administrative level, the national office is facing staffing shortages and their work is limited at this time. They will not be able to review legislation, etc. until staffing concerns have been addressed. In the meantime, we as a committee will continue to monitor all PA activities and work to support the branches as best as possible. Thanks for all your help.

We are all working on so many fronts, but we hope that with the resolution of the leadership issues in the House--we will be able to focus our efforts toward our priority issues of economic security in a very vibrant manner in 2023!

Today, we acknowledge the continued efforts of women on the front lines --- healthcare providers, nurses, personal care aides, first responders, teachers, social workers, and others in public service, who put themselves at risk to help those in need.

"The Colors of Courage: Gettysburg's Forgotten History: Immigrants, Women, and African Americans in the Civil War's Defining Battle" by Margaret Creighton who was, at the time of publication (2005), a professor of History at Bates College discusses the aftermath of the war. Drawing upon memoirs, letters, diaries and the like, the author tells the story of immigrants, women and African Americans who lived in and around the community during and after the battle. It is uniquely not a military history, but a history of human beings dealing with unimaginable circumstances.

TECHNOLOGY AND BIAS



We have been fighting conscious and unconscious biases we know exist, but as the technological world expands, we find ourselves facing a different kind of challenge – biases embedded in technology. This battle forces us to con template coding and algorithms, while recognizing that they are made by individuals who bring their own biases into their work.

A prime example of this issue was outlined in testing facial recognition technology, which was significantly less accurate in detecting darker skin females, specifically, while incredibly accurate in detecting and identifying white males. Coders are predominantly white men, so it is only natural that their data and work lean toward the familiar for them, created through a lens they understand and know, even if unconsciously biased.



There is a tendency to associate artificial intelligence with the future, particularly in its peaks of evolution, but it is important to recognize that artificial intelligence is founded in data obtained through historical compilations, so the past continues to reside in the future. The regulatory landscape recognizes this unfairness and is working toward implementing protections to account for the impact such biases can have in the future. It is imperative this topic stays on the forefront of advocacy as society moves to a technologically driven world where data analytics form the foundations for decisions.

They will use the \$200 towards the Sister to Sister Summit to be held on the Juniata College campus on April 7, 2023. As the awardees describe it, "the Sister to Sister Summit is an annual event hosted at Juniata College by AAUW @ Juniata and AAUW

Huntingdon Branch. Middle school girls/femininealigned identities apply participate in this day-long event. They apply using questions developed by AAUW National and are chosen by their school's guidance counselors. AAUW@Juniata chooses themes based on the girls' answers. After a theme is decided, the summit is designed using fun activities and facilitated conversation guides.

The purpose of this event is to help girls/femininealigned participants with honing their academic, social, and personal skills. Facilitators have experience



with similar problems or experiences that the participants will be going through. Participants will be holding conversations on topics such as identities, relationships, how social issues affect academics, future goals, family, and self-care.

The AAUW also encourages conversations about gender equity and women-based issues. Participants can gain a deeper understanding of the people around them and have new perspectives or advice on experiences/problems that they may be struggling with. Participants are also able to connect with different students across different schools and make new friends. Volunteers are also able to take on leadership/mentor roles.

The Sister to Sister Summit hopes to provide an authentic life-changing experience for everyone involved. We hope to create healthy connections with participants and the local community. Girls can experience the strength of having support systems and being able to communicate with others."

Congratulations to Ryan and Emma. We will look forward to hearing how the Summit went.

MISSION-BASED PROGRAMMING

AAUW State College sponsors speaker for Penn State Forum talk

In 2016, to celebrate its centennial, AAUW State College Branch established an endowment at Penn State. The endowment sponsors a speaker for the Penn State Forum Distinguished Speaker Series on an annual or biennial basis. The Penn State Forum brings renowned speakers to campus, several times a year, attracting about 200 Penn State faculty, staff, and community members to each event.

The forum series is modeled after the National Press Club Speaker Series, which includes a presentation by an invited speaker, followed by audience questions. The speakers address topics relevant to our times.

This year's AAUW State Collegesponsored event was held on December 1 with speaker Dr. Na'ilah Nasir. In addition to being the author of several books, Dr. Nasir is President of the Spencer Foundation, a leading funder of education research.

Her scholarly work focuses on issues of race, culture, learning, and identity. The topic of her talk was

Women Beware: The Bias of AI in Hiring

For a wide array of jobs, ranging from surgeon to investment banker to store clerk, employers use artificial intelligence and machine learning rather than humans to screen applicants. AI-based hiring technologies including resume-scans, one-way video interviews, and video games are relied upon by at least 407 companies within the Fortune 500 to rank and reject applicants. Because the AI is trained to find applicants similar to the highest-level existing employees (who are mostly male), they almost invariably discriminate against women. In fact, one machine-learning tool advised the employer to hire people named Jared who played lacrosse. A resume scanning tool developed by Amazon rejected any applicant who had the word "women" on her resume, even in instances when it was a positive like "National Women's Chess Champion" or "Captain, Women's Soccer Team." Employers claim that they can't be held accountable for this type of discrimination because a computer made the decision, not them.

Are women protected against AI-related gender discrimination by existing employment laws or are new ones needed? How do you even know if AI-based screening was used against you?

Speaker Biography

Lori Andrews is a University Distinguished Professor of Law at IIT Chicago-Kent College of Law and Director of IIT's Institute for Science, Law and Technology. She taught at Princeton, the University of Chicago, and the University of Houston Law School. She was an adviser on technologies to Congress, the World Health Organization, the National Institutes of Health, the Centers for Disease Control and Prevention, the federal Department of Health and Human Services, the Institute of Medicine of the National Academy of Sciences, and several foreign nations, including the Emirate of Dubai, the French National Assembly, and the G8 Science Ministers. She chaired the federal ethics advisory committee to the Human Genome Project.



Andrews received funding for her research from the National Science Foundation, the National Institutes of Health, the U.S. Department of Energy, the U.S. Department of Health and Human Services, the U.S. Congress, the M.D. Anderson Foundation, the Greenwall Foundation, and the Robert Wood Johnson Foundation. She is the author of eleven nonfiction books and three mysteries involving a fictional geneticist. She has been interviewed extensively by newspapers and frequently appears on television shows including CBS Morning News, The Today Show, Nightline, 60 Minutes, PBS NewsHour, and Oprah.

Professor Andrews' path-breaking litigation about technologies caused the National Law Journal to list her as one of the "100 Most Influential Lawyers in America." In 2005, she was made an Honorary Fellow of the American College of Legal Medicine for her "distinguished achievement in the field of legal medicine." Professor Andrews has won humanitarian awards for her pro bono legal work, including a successful 10-year odyssey to the Supreme Court to invalidate the patent on the breast cancer gene. The American Bar Association Journal describes Andrews as "a lawyer with a literary bent who has the scientific chops to rival any CSI investigator." She received her B.A. summa cum laude from Yale College and her J.D. from Yale Law School.
