PUBLIC POLICY UPDATES



National/Federal Issues Update

Here is a brief update of bills that have been introduced or that we expect will be introduced in the coming months.

 - Expect a confirmation vote later this month.

Welcome to Meghan Kissell, AAUW's new Senior Director of Policy & Member Advocacy

- Started at AAUW about one month ago; actually, returning to AAUW after working as field director 17 years ago.
- Background: did a lot of work on conservation out west, worked with the Human Rights Campaign (LGBTQ+ rights org.) in Deep South, worked with Tobacco Free Kids in mid-Atlantic and "tobacco states" (10 state region)
- Noting title as Senior Director of Policy & 'Member Advocacy' – recognition of how important advocacy is to our membership, making sure we're prioritizing advocacy of membership.
- Want to see how we can ultimately support, in a very focused way, outreach to members and advocates in your states.
- Looking for more input in thinking through how we can work together in partnership.

Keep checking your emails for information about upcoming rule changes for federal Title IX that impact many of our priorities. We are also expecting further advocacy around reproductive rights as AAUW National reacts to recent decisions pertaining to medication abortion.

Pennsylvania Update

Equal Pay in Pennsylvania

Pennsylvania's equal pay law has not been updated since 1967, when it was amended to exclude anyone subject to the federal Fair Labor Standards Act (FLSA) which means fewer people are covered. AAUW's Roadmap to Pay Equity in Pennsylvania recommends that any legislation include the following:

- Cover All Employees by removing exceptions for those covered by FLSA.
- Remove "establishment" limitations.
- Offer Protections against retaliation for discussing wages and not rely on/request//screen salary history.
- Clarify Employer Defenses which must be job related, a business necessity and not a sex-based differential. Defense does not apply if there is an alternative employment practice available.
- Establish Strong Legal Procedures and Remedies such as employer liable for compensatory and punitive damages, reinstatement, promotion or other equitable relief, high fines, expand Statute of Limitations.
- Comparable Worth giving equal pay for job with substantially similar skills.

Five pay equity bills have been introduced so far this session. The two bills that contain all the above criteria are:

- House Bill 98 – Rep. Donna Bullock (D-Philadelphia) includes race and ethnicity in addition to sex, imposes higher penalties on employers engaging in discriminatory practices, and would establish an Equal Pay Commission to research pay disparities.
- Senate Bill 421 – Sen. Steven J. Santarsiero (D-Bucks) and Sen. Maria Collett (D-Montgomery) This bill is the same as the one introduced last session and addresses all the AAUW Road Map areas. It does not increase fines.

Three bills address some of the pay equity issues. AAUW PA does not oppose these bills and would be happy to see any of them pass. However, we would prefer the more comprehensive ones.

- House Bill 356 – Rep. Mary Isaacson (D-Philadelphia) would require employers to post pay ranges for applicants and candidates for internal positions, upon hire, and thereafter.
- Senate Bill 36 – Sen. Tartaglione (D-Philadelphia) Of the AAUW criteria, it does not offer protections against retaliation, relying on salary history, holding employer liable, reinstatement or high fines.
- Senate Bill 386 – Sen. Judy Schwank (D-Reading) Restricts the right of prospective employers to ask applicants and employees about prior wage history but does not cover all employees.

The Family Care Act, House Bill 181 – Rep. Dan Miller (D-Allegheny) has been introduced. This bill which offers paid family leave is exactly the same as the bi-partisan bill from last session. As of

now no Republicans have signed on as co-sponsors. Please encourage previous sponsors to sign on. The Senate companion bill has not been introduced as yet.

Education Update

This spring starts the first round of school board elections for this incoming group of school directors. Education Voters has resources and great information about the importance of these elections.

Senator Ryan Aument

2030 Commission: Senator Aument placed a section in the School Code in 2022 that creates a commission to review the education system in Pennsylvania in very broad terms. This link provides the information that Senator Aument released in 2021 when he advocated for the creation of the commission.

Aument Bill to Improve PA's Economic Competitiveness Passes Senate Education Committee - Senator Aument

Education Advocates are pushing back on his characterization that PA schools are “broken”. As the Commonwealth Court asserts, it is the FUNDING system that is broken. Our schools serve over 1.6 million students (over 90% of all students in PA) and they are examples of institutions that work even under the worst conditions. However, all advocates note that our underfunded schools need more resources to provide the same opportunities that many students in our schools receive to be productive and successful adults. We will keep you posted on efforts to inform this commission on the true need to focus on funding.

Book Bill: We are still waiting for the reintroduced bill regarding curriculum and books (R-36). This bill was considered a book banning as it regulated the resources that were available to students in our schools.

School Funding Lawsuit Update: The defendants asked for reconsideration which was an expected strategy. The hearing is set for May 22, 2023, and the judge will then issue a decision about her original order. This decision could take a few months to receive. After the decision is announced, the defendants will have 30 days to appeal this final consideration by the judge. However, it is important to note that the original decision still stands, and NOW is the time for all parties to start the long process that will be required to solve the issues with PA's school funding system.

GENDER IDENTITY – WHAT DOES IT ALL MEAN?



In a world that is evolving in its understanding of gender identity, it is imperative that we, as individuals and an organization, maintain level footing on gender identity classifications to exercise impactful allyship and inclusivity.

The changing language landscape can be challenging to maneuver, which makes it all the more important to understand and process, so that we can make all those around us, as well as those seeking membership and community at AAUW feel comfortable, included, heard, and seen.

Gender identity is defined as a person's internal sense of one's own gender and sex, which may or may not be reflective of the *sex* that an individual is designated at birth, reflective of reproductive organs, hormones, and chromosomes. *Gender* is reflective of the behavioral, cultural, or psychological traits typically associated with one's sex. We may catch people using those words interchangeably at times, but it is important to know they are not and how we apply them shapes our understanding and treatment of gender identity.

Here are some common gender identities and their definitions:

Gender Identity	Definition ¹
Agender	A person who does not identify with any particular gender.
Androgyne	A person who has a gender that is either both masculine and feminine or between masculine and feminine.
Bigender	A person who identifies as having two genders.
Cisgender	A person who identifies as the sex they were assigned at birth.
Genderfluid	A person who has a gender identity and presentation that shifts between or outside of society's expectations of gender.
Genderqueer	A person who has a gender identity or expression that is not the same as society's expectations for their assigned sex or assumed gender.
Nonbinary	A person who does not experience gender within the gender binary.
Omnigender	A person who experiences and possesses all genders.
Polygender/Pangender	A person who experiences and displays parts of multiple genders.
Transgender	An umbrella term encompassing all people who experience and identify with a different gender than their assigned sex at birth would suggest.
Trans	A more inclusive term that covers those who identify as non-binary and those who are genderless.

While the above outlines some common gender identities, the list is not all encompassing and other subcategories exist.

You may find yourself asking, *why is this important? Why does it matter?* The truth is, the acceptance and empathy toward others, particularly those with different belief systems and personal identities and experiences, allows for the development and change of societal constructs and expectations. This transition supports equality of rights and protections under the law which the rest of society enjoys in privilege.

In the interest of inclusivity, it is imperative we understand individual gender identities and work to protect them all the same.

AAUW's National Conference for College Women Student Leaders (NCCWSL) is scheduled for May 31-June 3, 2023, at the University of Maryland. This will be the first in-person conference since 2019. AAUW-PA provides scholarships for Pennsylvania students to attend NCCWSL. This year we have awarded scholarships to four women:

Tyanna L. Alexander expects to graduate from West Chester University of Pennsylvania in 2024. She is majoring in Interdisciplinary Studies with a concentration in Business Law and Technical Writing. She holds an associate degree from Delaware County Community College, where she majored in Paralegal Studies and Business. She has worked as an estate planning paralegal since 2020. Tyanna is a first-generation American who wants to work toward immigration reform. She

plans to attend law school and build a career as an immigration lawyer and advocate for children. She hopes that attending NCCWSL will help hone her communication and leadership skills.

Megan Harth is a psychology major at West Chester University of Pennsylvania with a minor in Gender and Women's Studies. She expects to graduate in 2024. She founded the Feminist Club at her high school. Megan facilitates the Period Project at West Chester University, distributing 300 boxes of menstrual products to bathrooms across campus each week. She has served as an intern with the Domestic Abuse & Sexual Assault Crisis Center in Warren County, NJ. She hopes that NCCWSL will strengthen her skills as a resilient leader, skills she plans to bring back to her leadership positions on campus.

Successful organizations understand the past and plan for the future. The foundation of our work is the AAUW mission, vision, and values:

AAUW Pennsylvania branch members, national members in Pennsylvania, college and university members, and student associates will work locally to achieve national goals. Together, AAUW

Pennsylvania will be a welcoming and inclusive organization that serves as a significant resource and power.

Goal: Increase current AAUW PA membership with an emphasis on diversity, equity, and inclusion.

Strategy: Initiate the development of a virtual branch to recruit new members not inclined or unable to join physical branches; Members-at-Large (MALs); and members of disbanded Pennsylvania branches.

Assessment:

Virtual branch viability determined.

Goal: Recruit and develop new state leadership

Strategy: Frame the volunteer experience as part of a meaningful life by creating fulfillment (providing leadership opportunities which may not be offered through work or other experiences).and may substitute for work experience to create career opportunities.

Assessment: Nominations Committee puts forward nominees who are qualified to serve in open positions and honored to accept their nominations.

Goal: Increase Visibility of AAUW across the state

Strategy: Utilize applicable social media platforms to promote the goals, accomplishments, and activities of AAUW through coordinated campaigns that highlight branch programming and achievements with the goal of increasing membership engagement.

Assessment: Monthly e-newsletter distributed highlighting branch events open to all members. Funds established in 2023 budget to boost social media posts.

Goal: Put AAUW PA on sound financial footing

Strategy: Create a Finance Committee to build a 2023 budget that recognizes new pressures and changing opportunities impacting AAUW PA.

Develop guidelines for AAUW PA reserves.

Appoint a Finance Committee chaired by the Finance Officer and staffed by the Administrative Director.

Assessment: Finance Committee active and 2023 AAUW PA budget developed and approved by the Board. Decisions about guidelines for AAUW PA reserves reviewed and voted on by the board.

Goal: Improve coordination with and support for branches

Strategy: Secure input from branches about the need and desire for district programming. Reconsider District Coordinator positions with increased focus on programming. Explore

developing a program guide with Program Vice President focusing on Mission Critical programs and branch -based programs.

Assessment: Branches surveyed by District Coordinators about district-specific programs and shared with Board. Program guide developed and distributed at the 2023 Summer Retreat. Increased attendance and participation in AAUW PA developed programs. Increased partnership with branches in developing and sharing programs across the state.

MARGARET HART MCGRATH

DECEMBER 27, 1954-JANUARY 27, 2023

Margaret Hart McGrath, after completing a trip to Antarctica, died, in Ushuaia, Argentina, on January 27, 2023, at age 68, from complications of recently-diagnosed pancreatic cancer. An alumna of Wellesley College and of Harvard Business School, her career included time at the Ford Motor Company and at PPG Industries.



In retirement, Margaret was active in many civic organizations, particularly the American Association of University Women and the League of Women Voters, both in Pittsburgh and in Florida. She cherished time with her far-flung family and the leisurely pleasures of the garden.

Born in Detroit, MI, Margaret lived in Rochester, NY; São Paulo, Brazil; Mexico City, Mexico; and Toronto, Canada, before settling in Pittsburgh, PA, for 16 years. She moved to Lighthouse Point in 2016 to care for her parents, the late Frank and Mary Hart of Lauderdale-by-the-Sea. Margaret is survived by her husband of 33 years, Edward McGrath; their children, Philip and Terry; and her sister Susan Hart-White (Richard), as well as numerous nieces and nephews, other relatives, and beloved friends. Her sister Ann Ramish (Timothy) predeceased her, as did their parents.

MISSION-BASED PROGRAMMING

AAUW Carlisle Civics 9-1-1

The Public Policy Committee's non-partisan civics engagement series, Civics 9-1-1, was a great success. In the first two of this three part series, we explored our constitutional foundations and long-held democratic norms, discussed how to separate facts from disinformation and how to have a civil conversation. Part three addressed the election system and how citizens can become engaged in local community and civic activities.



Session I, “American Democracy: What We Believe”, was held on March 21st with over 35 people in attendance. AAUW Carlisle members, Dr. Marybeth Ulrich, Professor of Government at the U.S. Army War College and Judge Mary (Cherry) France (retired), U.S. Bankruptcy Court, Middle District, PA, discussed our Constitutional Foundations and Principles of Democracy. The audience also learned about citizen obligations that, when followed, will serve to promote a healthy and sustainable democracy.

AAUW Carlisle PPC members: Nancy Sigrist, Marybeth Ulrich, Mary France, Kate Elkins, and Kathy Gates

Session II on March 30th, entitled “Fact or Fiction: Disinformation & Civil Discourse”, featured Cumberland County Commissioners Jean Foschi and Vince DiFilippo who discussed the importance of finding common ground, providing examples of how they work across the political aisle to further the people’s business, and Chris Baxter, Founder and Executive Director, Spotlight PA, who discussed how to identify disinformation and the effect of social media.

Elkins moderated and guided attendees through 9 tips for effectively exchanging ideas with those who have opposing opinions and different values.

Session III on April 4th was “Wanted: Informed, Engaged Citizens”. Leading a discussion of elections and other civic engagement opportunities was Bethany Salzarulo, Director, Cumberland County Bureau of Elections, Paula Bussard, President, Board of Directors, Carlisle Area School District and Stephen Caruso, Capitol Reporter, Spotlight PA.
