## PUBLIC POLICY UPDATES



Retreat 2023 in Gettysburg allowed for excellent discussion of AAUW Public Policy Priorities and we were honored to have Barb Price summarize the work she has been doing on the national level for past years. We are proud of her work for all of us!



#### **AAUW Public Policy Priorities**

AAUW has always been political but has never been partisan. We have a long herstory of creating social change through public policy efforts like endorsing legislation. Political work can be characterized by shared values, and working toward a common goal that is best for the community. AAUW takes political stands and influences public debate on critical issues based on the values in the member-adopted Public Policy Priorities. <u>https://www.aauw.org/resources/policy/aauw-public-policy-priorities/</u>

Looking at the **118<sup>th</sup> Congress, t**he reality is that Congress is divided with different parties in the majority in the House and Senate. This can make getting to a consensus difficult. However, AAUW will not sit back and wait. We will continue to work on legislation that affects women and girls. The legislation AAUW will be tracking over the next year and a half includes:

- The Family Act addresses paid leave
- The Healthy Families Act addresses sick leave
- Legislation to address college affordability and student debt
- The Gender Equity in Education Act
- The Equality Act addressing LBGTQ+ discrimination
- Equal Rights Amendment AAUW is focused on getting legislators to sign the discharge petition on House Joint Resolution 25 (H.J. Res. 25). This would allow a vote on the resolution to remove the ratification deadline and affirm the Equal Rights Amendment as the 28th Amendment to the Constitution. We contacted the two Pennsylvania Legislators to ensure that all of PA's representatives who cosponsored the resolution were on the discharge petition.

AAUW PA has its own public policy priorities which are due to be reviewed and updated next year. <u>https://aauw-pa.aauw.net/policy/priorities/</u>

Like the federal congress, The PA legislature is also divided. While progress has been made in passing some bills in the House, we will need to push to get them passed in the Senate.

As a result of our priorities, AAUW PA actively supports the following legislation

- Pay Equity HB 98 (Bullock) and SB 421 (Santasiero)
- Living Wage HB 1032 passed the House 6/29/23 Sen Dan Laughlin has the same bill

- Efforts to address School Funding and HB 1422 Cyber Charter reform passed the house July 7.
- Paid Leave HB 181 (D. Miller) Senators Maria Collette (D-12) and Devlin J. Robinson (R-37) have issued a Co-sponsorship Memoranda to re-introduce the "The Family Care Act," bi-partisan legislation that would establish a statewide family and medical leave insurance program. They are asking their fellow senators to join them in sponsoring this important legislation to help hard-working Pennsylvanians take care of their families as unexpected and protracted illness can strike anyone at any time. #### Budget Update:

On August 3, Governor Shapiro signed the Commonwealth's budget for the fiscal year beginning July 1st- yes it was late. We are happy that the budget was signed but many of the components of the budget (\$1 billion) cannot be completed with enabling legislation. On August 30, the Senate is scheduled to return to address a narrow set of issues that could lead to a release of much-needed funding for hospitals, schools, and communities. Since this action is after the submission date for the Keystoner, the Public Policy chairs will receive updates as the process moves into the fall. <u>Pa.</u> Gov Shapiro signs \$45.5B budget but lawmakers have more work to do – Pennsylvania Capital-Star (penncapital-star.com)

#### **Important Election Information:**

This fall's election is important with statewide judicial elections that could shape the Supreme Court and crucial school board elections. Here are important dates from the LWVPA website that will assist us on preparing for these upcoming key steps for the November election:

#### **General Election:**

**October 23, 2023**: Last day to REGISTER TO VOTE in the November election **October 31, 2023**: Last day to apply for a mail-in or civilian absentee ballot (ALL registered voters in Pennsylvania can apply for a mail-in ballot)

#### November 7, 2023: GENERAL ELECTION DAY

November 7, 2023: Last day for County Boards of Elections to receive voted mail-in and civilian absentee ballots (must be received by 8:00 P.M. on election day - postmarks are not enough.) November 14, 2023: Last day for County Boards of Elections to receive voted military and overseas mail-in and civilian absentee ballots (must be submitted for delivery no later than 11:59 P.M. on November 6th)

**GENERAL Election:** polls are open from 7 A.M. to 8 P.M. on November 7, 2023. Education Updates:

This fall, the <u>Basic Education Funding Commission</u> is meeting throughout the state to discuss the need for adequately and equitably funding our school districts. With the Commonwealth Court decision declaring our funding system unconstitutional, it is essential that this Commission address our funding needs. Here are the dates that you might be able to witness the Commission in action:

The current schedule is:

- September 12 in Allentown
- September 13 in Harrisburg
- September 14 in Philadelphia
- September 21 in Lancaster
- September 28 in Hanover
- October 5 in Hazleton
- October 11 in Pittsburgh
- October 12 in Lemont Furnace
- November 2 in Enola
- November 9 in Bedford

Hearing details and agendas will be announced closer to the dates. The public can submit comments to be entered into the record via the Contact Us section of the commission's website: www.basiceducationfundingcommission.com.

We are witnessing increasing attacks on school districts from book bans to policy restricting the rights of LBGTQ+ children. We look to have programs in the fall to address these topics as well as any suggestions members may have to meet their needs for engaging in public policy priorities. ### THANK YOU AAUW PA RETREAT ATTENDEES!



According to AAUW CEO Gloria Blackwell, a featured speaker at the AAUW-PA retreat, only 1.9 percent of overall charitable giving goes to organizations dedicated to women and girls. In support of AAUW's mission to promote equity for women and girls, retreat attendees made contributions totaling \$1,055 for AAUW. The breakdown is as follows: \$470 to AAUW National, \$585 to AAUW PA.

#### Grants, Fellowships and Endowments

AAUW just awarded a record \$6.3 million dollars in grants and fellowships to 285 recipients, for a total of \$135 million since the program's inception in 1888.

AAUW holds millions of dollars in endowments which were created by branches and members, predominately in the last century. This Spring I learned that some Pennsylvania branches were unaware of endowments that they or their members founded, and how the monies generated by these endowments were used to advance the education and research agendas of women. In some

cases, their endowments were used to support programs of community groups that empower women and girls.

Below are directions for how to access endowment information on AAUW's website. Branches might be surprised to learn that their endowments are funding students in their own backyards—a rich resource for programs.

Please note that the information only goes back to 2004-5.

# How to Search for Individuals Who Have Received AAUW Grants from a Branch or Personal Endowment (*The York (PA) Branch is used as an example*)

- 1. Click on this URL: <u>https://www.aauw.org/resources/programs/fellowships-grants/directory-of-recipients-sponsors/</u>
- 2. Click on *Search the Directory* in the red box at the bottom of the page.
- 3. In the left column, click on Search for Sponsors.
- 4. Under Fund No/Name, type in York and browse until you find the Branch.
- 5. Another option to choose a state, in this case Pennsylvania. This is a way of seeing ALL endowments established by Pennsylvania branches and members. Select a sponsor (you might find some surprises).
- 6. On the lower left, click on Search for Recipients.
- Retrieve a list of the 19 women who have received funding from the York endowment, dating back to 2004-5. If you wish, go directly to: <u>https://www.aauw.org/fellowships\_directory/#fnd1737</u>
- 8. Click on the women's names to learn more about them and their research. They are impressive!

### MISSION-BASED PROGRAMMING

#### AAUW Fox Chapel presents "The Banning of Books: A Panel Discussion"

On Tuesday October 10, 2023 at 10:00 AM at Cooper-Siegel Community Library, 403 Fox Chapel Road, Pittsburgh, PA, speakers Paul Kohberger, Jill McConnell, and Fran Bogos will lead a panel discussion.

Recent years have seen a record-breaking number of attempts to ban books, according to the American Library Association. In some cases, this effort has turned school districts and libraries into battlegrounds. Book censorship will be the focus of a panel discussion sponsored by the American Association of University Women (AAUW), Fox Chapel Area Affiliate, on October 10 at Cooper-Siegel Community Library. The program, free and open to the public, begins at 10:00 AM.

Book censorship in the U.S. has been around since 1637, when Thomas Morton's **New English Canaan** was banned by the Puritan government. It's in illustrious company: The **Bible**, works by William Shakespeare and Mark Twain, Harriet Beecher Stowe's **Uncle Tom's Cabin**, and novels by Walt Whitman, Margaret Atwood, Ernest Hemingway, George Orwell, Dan Brown, and even J. K. Rowling have all made "the list". Books with religious themes are frequent targets of book censors, as is material on sexuality and race; "obscenity" is often cited as a primary reason to declare a text illegal.

School boards are among the most likely groups to initiate book challenges, usually at the request of parents. Political and religious groups often weigh in as well, and occasionally library patrons.

Our panel of three library and book specialists will address the controversy surrounding book censorship and kickoff the discussion: Paul Kohberger is a retired University of Pittsburgh librarian and a current board member of the Allegheny County Library Association; Jill McConnell has been the Executive Director of Cooper-Siegel Community Library since 2014; and Fran Bogos is a retired reading specialist in the North Allegheny School District, teaching at the junior and senior high school levels. Their comments will be followed by questions from the audience, presented to the panelists in written form.
