

MESSAGE FROM THE PRESIDENT



With so much happening in our country, it's difficult, at best, to stay on top of the breaking news. Many find the news so upsetting they temporarily step away to protect their own mental health.

Yesterday, I was reading a post from author Bob McKinnon on the topic of *smiling*. He notes the average child smiles more than 400 times a day, and the average adult thirty times. Women smile sixty times a day, and men only eight. Ouch!

We all need to find opportunities to smile. The news is grim but the impact of the work we do as members of AAUW is anything but. Indulge me for a minute and read about some of the ways your membership and donations helped women in 2024.

- AAUW is the oldest non-institutional major funder of graduate women's education, providing \$146 million in fellowships and grants to more than 14,000 women in 50 states, the District of Columbia, Puerto Rico, and Guam as well as in 152 countries worldwide since 1888.
- AAUW awarded \$6.2 million to 276 Fellows and Community organizations in 2024. We awarded 18 Community Action Grants supporting U.S. organizations advancing gender equity for women and girls locally.
- AAUW is actively involved with key United Nations (UN) events including the Sustainable Development Goals (SDG) Summit and the 68th Commission on the Status of Women. AAUW also partners with Lehigh University in Pennsylvania to support two college youth representatives who are engaged with the UN.
- In 2024, some 500 women college students from 125+ institutions came together at the University of Maryland to prepare for future leadership roles. While NCCWSL will be overseen by NASPA (National Association of Student Personnel Administrators), AAUW will continue to be involved and supportive. This year, a number of our Pennsylvania branches will once again send students to NCCWSL.
- The Women's Economic Empowerment Initiative provided 6,157 women with the essential tools to succeed financially. AAUW's salary negotiation workshops led to an 18 percent increase in participants' confidence in their ability to negotiate.
- Members sent 47,000 impactful messages to elected officials via AAUW's Two-Minute Activist.
- AAUW's volunteer Lobby Corps visited more than 400 congressional offices to advocate on behalf of our membership.
- AAUW signed on to more than 100 coalition letters supporting issues affecting women and girls.

In principle and in practice, AAUW values and seeks an inclusive membership, workforce, leadership team, and board of directors. There shall be no barriers to full participation in this organization on the basis of age, disability, ethnicity, gender, gender identity, geographical location, national origin, race, religious beliefs, sexual orientation, and socioeconomic status.

That's a good bit of impact. Yet, only 17 percent of our members donate to National. It is not how much you donate; any amount is appreciated. In addition to the Greatest Needs Fund, you may have noted there are now two new options to donate: the Defend Higher Education Fund and the Public Policy Fund.

Your neighbors, friends, and coworkers may be looking for an opportunity to respond to many of the alarming steps being taken by the new administration regarding the government's legal commitment to ensuring women's educational opportunities and economic security. This is the time to reach out and tell our story. A good number of our branch presidents and public policy chairs have written letters to the editor and opinion pieces for Pennsylvania newspapers. This raises our visibility and lets people know what our organization stands for.

Frequently I am asked about the size of AAUW's membership. At the close of 2024 there were 41,000 total members, Fifty-three percent of the members belong to branches with 10-49 members and only 10 percent belong to branches with 100+ members. Pennsylvania has approximately 1,500 members and is the fifth largest state in membership, Clearly, our members' active participation and support matters!

Each of us is trying to find our way during this turbulent time. No matter where you stand on the partisan side of issues, AAUW priorities are facing unprecedented attacks. Higher Ed is seeing their funds frozen, and voting rights are being attacked. Diversity, Equity, and Inclusion - yes, we are writing it out now- are assaulted every day. Each day, we face new challenges. AAUW is taking important actions needed to elevate and protect our priorities. There are so many ways to engage, such as outreach to lawmakers, letters to the editor, attending trainings, and participating in rallies. Our

members are our strength, and we are here to support your efforts to uphold our values. If you meet with your lawmakers, both state and federal, please use this <u>form</u> to report the meeting to the Public Policy Committee.

Protest Guidelines: National will be releasing more formal guidance, but for now, the National Public Policy team recommends that we focus on positive messages such as "AAUW PA Supports Higher Education Freedom, Diversity, Equity and Inclusion, and the rights of all people to secure economic stability." Keeping the focus on our priorities and what we support is acceptable in a partisan world. They recommend that we avoid personal attacks and language that would be viewed as partisan. If you attend a rally, you can go as an individual without displaying your affiliation with AAUW, then you can do as you please. Just remember that AAUW is non-partisan and needs to be kept out of partisan displays of support or anger.

We will keep you posted on formal guidelines.

SAVE ACT:

The Safeguarding American Voters Eligibility Act was passed out of the US House of Representatives on April 11, 2025. This act will potentially disenfranchise millions of voters, especially women who changed their names upon marriage. No bills should be making it harder for citizens to exercise their right to vote. Contact our Senators to stop this harmful bill from moving forward.

Education Update: PA Department of Education has certified to the US Department of Education that all districts in Pennsylvania follow applicable federal and state laws that ensure our students and schools are protected. Diversity, Equity, and Inclusion are protected in PA. Read<u>the letter</u> sent to the USDOE. Kristina Moon, Esq. of the Education Law Center, noted that it is "an advocacy win" for PA that the Department sent this letter to the US Department of Education. With threats to cut federal funding to schools, Governor Shapiro has stated that he will continue to monitor the situation.

In state Education news: PA Schools Work is hosting its annual Advocacy Day on May 13th in Harrisburg. Please join advocates from around the state as we fight for adequate funding to meet the constitutional mandate ordered by the Commonwealth Court. Student Impact Mini-Grants and NCCWSL

January until the end of April is THE busiest time for the AAUW Pennsylvania College/University Liaison. Not complaining because the work we do with **Student Impact Mini-Grants** and **NCCWSL** grants is VERY fulfilling and rewarding. Below is a summary of the results from each.

Student Impact Mini-Grants

Applications were open until February 15, 2025. Six applications were submitted for committee review. The four approved events are summarized below. This quote from a recipient report explains exactly why AAUW Pennsylvania sponsors \$500 Student Mini-Grants each year.

Your support empowers us to inspire girls to become successful and well-equipped young women by offering them resources, education, and networking opportunities—one event at a time.

Respect Head Covers; Stop Stereotyping--Lamia Dawood, graduate student and AAUW student member at Indiana University Pennsylvania.

Lamia Dawood, the moderator, opened with a presentation about the importance of inclusivity and acceptance at IUP. She explained that women wear head coverings for various reasons, and moving away from stereotypes is important.

Attendees were encouraged to share experiences concerning remarks they received about their looks that made them uncomfortable. The panel helped everyone to express themselves and to feel that they are not alone. There was laughter, empathy, and some tears remembering old stuff that they wished to forget. The moderator encouraged everyone to express themselves and not to feel judged and to never let a comment from anyone to make them change themselves. The moderator closed the event by confirming the resources that IUP offers students to seek help if they need to talk to someone or report an incident.





Equal access to period products in Huntingdon Area School District schools--Heather Small, undergraduate, AAUW student member at Juniata College and President of the AAUW Juniata College student organization.

AAUW Juniata College wanted to provide period products for girls in the Huntingdon Area School District's elementary, middle, and high schools. Our purpose is to provide equal access for those who may not be able to afford their feminine products, a resource in case a girl experiences her first period at school, or security for those with irregular periods/don't know how to track their periods. With this, we hope to normalize period products and provide necessary supplies for women.

After contacting nurses in the five schools, on March 12 and 14, pads were delivered to elementary schools and both pads and tampons were delivered to middle and high schools. Every school principal and nurse were very happy to accept the donations.



Women in STEM Careers--Monjeana Henderson, undergraduate, AAUW student member, and President of AAUW Penn State Greater Allegheny Student Organization.

Encourage high school girls to pursue higher education and STEM careers with a visit to campus and an event featuring career awareness activities, a panel discussion with recent graduates sharing their journeys, lunch, and the ability to network with women faculty at Penn State Greater Allegheny.

On February 28th, 60 students and four chaperones from four high schools joined four students and nine faculty from Penn State Greater Allegheny for an inspiring event. Many high school students attended during school hours and left the event feeling inspired and more interested in pursuing higher education. The event successfully promoted STEM careers and higher education.

Honoring Women's History Month – Colette Costlow, undergraduate, AAUW student member at Saint Francis University and AAUW Pennsylvania intern during her junior and senior years. And President of the Saint Francis University Literary Club.

The Literary Club organized this March 20th event to recognize Women's History Month by honoring the female faculty at Saint Francis University. The event began with a reception in the lobby. Copies of *Invisible Women* by Caroline Criado Perez and fliers about how to get involved with AAUW were given to interested students. Sparkling cider was passed to all attendees for a "champagne toast" to our female panelists. Several female faculty members were invited to participate in a panel. Each panelist shared why Women's History Month is important to them, along with a woman who inspired them. The school newspaper, *The Tronbadour*, printed the story about the Literary Club being awarded the AAUW Pennsylvania Student Impact Mini-Grant.

Many attendees and panelists approached Literary Club members to express their satisfaction with the event. Attendees gained insights and appreciation of the female faculty at the university. Colette wrote in the required summary report that the "positive aspect of planning this event was knowing that we were uplifting inspirational women at SFU."



At the branch January 5, 2025 board meeting an active discussion on how to engage, educate and advocate for equal pay for equal work led to the branch forming an Equal Pay Committee. The committee led by Peggy Schmiedecke includes Debbie Rosenfelder, Francie Cech, Sylvia Lynn and Annahid Samiljan. We started by identifying our focused activities:

- Held Zoom Training Session led by Peggy; on how to hold a meeting with an elected official, identify the legislators, identify PA Bills, updating Representative on AAUW <u>The Not So Simple</u> <u>Truth About the Gender Pay Gap</u>, and Equal <u>Pay Day Calendar 2025</u>, build the agenda for the meeting Peggy, Franci, Debbie
- Francie contacted District 30 Representative, Dr. Arvind Venkat, scheduled the meeting and firmed up that we would discuss HB 630 Improved Equal Pay, HB 926 Violence Prevention in Health Facilities, HB200 Family & Medical Leave, HB274 Unemployment Compensation Eligibility related to Domestic Violence.




Representative Venkat met with Francie Cech, Peggy Schmiedecke and Sylvia Lynn.
