#### President's script from the AAUW PA Summer Retreat:

"Deb first joined AAUW Huntingdon in 1989 and became president of the branch from 1996-2000 and again from 2015-2024 (serving as president for a total of 13 years). Throughout her years with the Huntingdon branch she has served in numerous positions, including Webmaster, and received the branch's Outstanding Woman Award twice.

During her tenure with the AAUW Pennsylvania Board, Deb also has worn many hats. She served as South-Central district coordinator in 1992-96, co-president with Kate Sweney from 2008-2010, and college/university liaison from 2010-2016. She currently serves as co-chair of the nominating and elections committee and as bylaws chair.



Speaking of Bylaws: many of you know Deb from her attention to state and branch Bylaws. She is highly knowledgeable and meticulous when it comes to bylaws and this serves all of us well.

Never being satisfied to sit on the state board and a branch board, Deb also is a member of the Carlisle and Washington, DC branches. When Deb and her husband moved to DC, she was quick to join the DC branch and raised her hand to manage their bylaws. In addition, she signed up for the Lobby Corps. While this was all new to her, she decided it also would be a good learning experience, focusing her to stand for our mission with federal legislators and their staffers.

Deb currently serves on the AAUW National Advancement Committee, representing Pennsylvania (the 4<sup>th</sup> largest AAUW membership state). In July, she will serve as Vice Chair of the committee.

Professionally, Deb was Assistant Professor of English and Director of the Language in Motion Program at Juniata College through 2023. She holds an MA and Ph.D. in Slavic Languages and Literature from Ohio State. I am pretty confident she speaks fluent Russian which gives us all an idea of her excellence in language. Deb continues her very strong commitment to students, reviewing mini-grant proposals and applications for NCCWSL. She clearly has been a wonderful mentor to many students over the years.

## 2025 AAUW PA GATEWAY TO EQUITY HONOREE DONNA BULLOCK "A BEACON OF PUBLIC SERVICE AND ADVOCACY"

Donna Bullock, the recipient of this year's Gateway to Equity Award, embodies the true spirit of public service. Her career journey began as a Youth Advocate after college, where she focused on supporting children facing the same challenges she once did living in unstable housing and grappling with food insecurity. After earning her law degree, Donna continued her mission to help those in need, joining the Community Legal Services' Child Care Law Project within the Economic Development Unit. Her work would go on to significantly impact the lives of Pennsylvania's women and children.



Throughout her career, particularly in her role as Special Assistant

to Council President Darrell L. Clark in Philadelphia, Ms. Bullock has exemplified how to effectively serve and uplift our communities.

In August 2015, Donna Bullock was elected to represent the 195th Legislative District in a special election, where she has since become a strong advocate for working families. In the 2023-2024 Legislative Session, she served as the Majority Chair of both the Children and Youth Committee and the Ethics Committee. Additionally, she held the distinguished position of Chair of the Black Legislative Caucus. Representative Bullock's leadership has been marked by a steadfast commitment to advancing legislative initiatives that fund public education, create jobs, and build healthy, sustainable communities. Her advocacy extends to championing equal pay, increasing the minimum wage, promoting clean energy and environmental justice, ensuring quality public schools and pre-K education, and fostering sustainable community development.


Representative Bullock holds a BS in Administration of Justice from Rutgers University and a JD from Temple University's Beasley School of Law.

For the American Association of University Women (AAUW) of Pennsylvania, Rep. Bullock's support has been unwavering. She has spoken at every pay equity rally hosted by AAUW PA at the state capital. In her final legislative session, she introduced HB 98, the Equal Pay Bill, which passed the House of Representatives on May 6, 2024.

Currently, Donna Bullock serves as the CEO of Project HOME, an organization dedicated to empowering individuals and families to break the cycle of homelessness and poverty. Through its mission, Project HOME, works to address the root causes of poverty and help all people realize their fullest potential, both as individuals and as active members of society.

Founder Sister Mary Scullion stated on Ms. Bullock's appointment: "Donna is compassionate, servant-minded and mission-driven," Scullion said via press release. "She's spent her career advocating for the underserved, fighting to ensure everyone has a voice. I'm certain she'll bring that same fighting spirit to her work at Project HOME, and I look forward to supporting her as we strive to make our vision a reality: None of us are home until all of us are home."

We are honored to have Ms. Donna Bullock as our champion and recipient of the Gateway to Equity Award.

### FIVE-STAR RECOGNITION PROGRAM

The AAUW Five Star National Recognition Program is designed to help branches like yours align with AAUW's strategic priorities and advance our mission of achieving gender equity for women and girls. By participating in this program, your branch contributes to a strong network of advocates, elevating both your local impact and our collective efforts nationwide. The 2025 Five Star criteria were:

**Communications and External Relations** (meet three of the five criteria): designate a communications officer and follow AAUW on all social media platforms it uses; share 3-5 posts aligned with AAUW's mission per quarter on social media; include information from AAUW National in branch newsletters at least quarterly; include information about Equal Pay Days in branch communications, including social media; ensure all branch leaders subscribe to AAUW emails and share the email re-subscribe link with members quarterly.

Debbie has lived a lifetime of service as a CEO of a social service organization, a Vice President of the Bradford Regional Medical Center, and as a nurse. As an employee and volunteer, she has helped make Bradford and the region a better place because of her integrity, compassion and her history of standing up for the rights of all individuals, especially those in need of an advocate.

#### YWCA Carlisle & Cumberland County and Cumberland County Commission for Women

**YWCA Carlisle & Cumberland County** works tirelessly to improve the lives of people, and in particular women and children, in our area. Maddie Young, Executive Director and her staff advance our mission of equity for women in almost everything they do. Some of their programs include Sexual Assault and Rape Crisis Services, Educational Programming for both children and adults, Little Wonders Preschool and Pad Pantry to address period poverty by distributing feminine hygiene products. They work with other community organizations on issues like racial justice and bringing different neighborhoods together. Recently, the YWCA rolled out their "Persimmon Awards" to honor diverse achievements of women in Cumberland County who exemplify peace, justice and dignity for all. This organization truly lives up to their logo by-line, "eliminating racism and empowering women"!

The **Cumberland County Commission for Women** was first organized in 1999 and is currently made up of 25 volunteer members. The principal goal of the Commission is to increase opportunities for Cumberland County women and girls by identifying and promoting awareness of pertinent issues. In 2024, Cumberland County PA Commission for Women organized a town hall that focused on barriers and access to affordable child-care and possible solutions. Topics included the challenges that providers are facing along with the economic impact the high cost has on parents and children. This well attended event put an additional spotlight on an issue that our community identified as a primary barrier for economic equity for women during the Beyond Suffrage Forum staged by the Carlisle Branch and subsequent white paper that we delivered to the State Assembly a couple of years ago. Going forward, the Commission plans an additional event in 2025 to further explore the childcare issue along with other events to help women and girls navigate the complexities of housing and healthcare systems.

A full-professor of Biology at Pitt-Johnstown and 2024 winner of the Pitt Chancellor's Public Service Award, Christine is a highly engaged community organizer in Johnstown, working with Hope4Johnstown, Unity Coalition of Southern Alleghenies, CommuniTEAMS, and Johnstown Animal Welfare Society, among others.

#### Lansdale

#### Suzan Neiger Gould - Executive Director, Manna on Main Street

Suzan has served as the Executive Director of Manna on Main Street since 2012. Under her leadership, Manna has expanded its reach and deepened its impact on the community. When Manna relocated to North Penn Commons in the fall of 2016, Suzan envisioned even greater possibilities to serve those facing economic instability. Manna already offered vital services, yet Suzan saw an opportunity to do more, particularly by addressing joblessness, a root cause of instability.

Inspired by the Catalyst Kitchens model, which is a national network of social enterprises and nonprofit teaching kitchens—Suzan proposed a bold initiative to Manna's Board of Directors (which was approved), to provide a workforce development program providing free, hands-on culinary training and employment readiness, coupled with individualized social services.

Manna named the initiative the Common Grounds Training Program, which is an 8-week course designed to equip participants with food service and employment skills, preparing them for meaningful, sustainable careers. Through this innovative program, Manna transforms lives and fosters lasting change.

For many women raising children on their own while facing economic hardship, access to job training and stable employment is nothing short of life changing. Suzan's vision and leadership continue to open doors of opportunity, which truly embodies the spirit of the Gateway to Equity Award.

#### Reading

#### Girls on the Run

Girls on the Run of Berks County was established in 2013 offering fun, evidence-based programs designed to inspire girls of all abilities to recognize and embrace their inner strength and to make meaningful connections with others. Focused on girls in 3rd - 8th grades, our programs inspire participants to recognize their inner strength, increase their level of physical activity, imagine their possibilities and confidently stand up for themselves and others.

Over 6000 girls in over 80 schools & community sites across Berks & Schuylkill counties have participated in Girls on the Run programming. Our programs (Girls on the Run for 3rd - 5th grades and Heart & Sole for 6th – 8th grades) take place over 8-10 weeks in Fall and in Spring, with teams meeting twice weekly throughout the season. Teams are led by trained, volunteer "coaches" who deliver lessons that blend physical activity with life skills such as managing emotions, forming friendships and giving back to our communities. Each season culminates in a celebratory 5K that gives participants a tangible sense of accomplishment.

#### Strawberry Fields

"Empowering People, Enriching Lives" - This non-profit organization enables our fellow citizens with intellectual and mental disabilities to become part of the larger community through its services and advocacy. Through its entrepreneurial initiatives, Strawberry Fields has brought marginalized individuals into the workplace, allowing them to earn a living, enhancing their economic self-sufficiency and helping them to integrate into the community at large.

## AAUW PA Annual Business Meeting

96<sup>th</sup> Edition, May 3, 2025 Minutes

#### Registered: 159 members In attendance: 27 members

AAUW Pennsylvania President Cindy Hall called the 96th Annual Business Meeting to order at 9:05 am. Attendees were reminded via email announcements of this virtual meeting to all members of branches on April 8 and April 27, and to Branch Presidents on March 31, 2025.

#### Introductions

Cindy Hall introduced AAUW Pennsylvania Past Presidents in attendance: Ann Pehle, Barbara Price and Deborah Roney Members serving on AAUW national committees were recognized including: Advancement: Deb Roney (Huntingdon) Governance: Ajla Laussegger Co-Chair Nominating: Cindy Hall (State College) AAUW Pennsylvania State Board members in attendance were introduced: Ann Echols, Rebecca Gardner, Sally Kalin, Sandra Miller, Ann Pehle, Charlotte Ridge, Deb Roney, Karen Wellin, and Lori Woods

#### **Credentials Report**

Secretary Charlotte Ridge presented the Credentials report (below.)

Each member of the State in good standing as of the official notice of this meeting is entitled to one vote. ARTICLE XVI. MEETINGS OF THE AFFILIATE. Section 8. states "The quorum shall be a majority of the registered eligible voters at an election event (branch meeting, electronic voting, paper ballot voting, or other Board of Directors approved method of voting) who cast a vote."

As of April 27, 2025, there were 1,426 eligible voters from 26 branches and 26 National and State members. Of these, 159 registered for this meeting either by voting in one or both of our online elections and/or by attending today.

Secretary Charlotte Ridge made a motion for the adoption of the Credentials and Bylaws Chair Deb Roney seconded. Prior to attendees voting electronically on the adoption of the Credentials report, President Cindy Hall asked members if there was any discussion. There was no discussion, and attendees were asked to vote electronically on the adoption of the Credentials report with a yes vote if in favor and a no vote if opposed. The vote was unanimous in favor. President Cindy Hall declared the presence of a quorum.

#### Adoption of Rules of Order and Agenda

President Cindy Hall introduced Bylaws Chair Deb Roney to speak to the adoption of the Annual Meeting Rules of Order and Agenda (below.) Registrants were given access to the Rules of Order along with the agenda. "Pursuant to AAUW Pennsylvania bylaws (May 2024), Article XVI. Section 7. Meeting Rules., "Affiliate annual business meeting rules shall be proposed by the Affiliate Board of directors and considered by each Affiliate annual business meeting as its first order of business."

Bylaws Chair Deb Roney moved for the adoption of the Annual Meeting Rules of Order and Cheryl Towers, Fox Chapel seconded.

Prior to attendees voting electronically on the adoption of the Annual Meeting Rules of Order President Cindy Hall asked attendees if any items should be discussed. Attendees had no discussion topics and were asked to vote electronically on the adoption of the Annual Meeting Rules of Order with a yes vote if in favor and a no vote if opposed. Secretary Charlotte Ridge recorded 22 yes votes and 0 no votes.

President Cindy Hall announced the Rules of Order were adopted.

Bylaws Chair Deb Roney moved for the adoption of the agenda for the Business Meeting as it appears in the linked materials and Public Policy Chair Sandra Miller seconded.

Prior to attendees voting electronically on the adoption of the agenda President Cindy Hall asked members if there was any discussion. Attendees who were in favor of the adoption of the Annual Meeting Rules of Order and Agenda as amended were instructed to vote yes if in favor and no if opposed.

Secretary Charlotte Ridge recorded 23 yes votes and 0 no votes. President Cindy Hall announced the agenda was adopted.

#### Minutes of the 2024 State Annual Business Meeting

President Cindy Hall asked Secretary Charlotte Ridge to report on the Minutes of the 95<sup>th</sup> AAUW Pennsylvania Annual Business Meeting held on May 4, 2024. Secretary Charlotte Ridge reported the minutes of the last annual business meeting were reviewed by Pat Byerly (Pittsburgh and Indiana County Branches) and Sally Kalin (State College Branch). Meeting attendees were reminded that a link to the minutes was included in the agenda with a link sent to registrants of today's meeting.

President Cindy Hall proposed dispensing with the reading of the minutes if there were no objections. Hearing no objections from attendees, members were asked if there were additions or corrections to the minutes. There were two corrections from Bylaws Chair Deb Roney:

- Under the Bylaws proposals on p. 12 of the Business Meeting yearbook quoted here, the "11" should instead be the word "all": "Bylaws Chair Deb Roney indicated 11 proposed changes to the AAUW Pennsylvania bylaws were approved" [...]
- On p. 13 under Adjournment, there is a typo in the branch name "Huntingdon."

President Cindy Hall asked if there were any objections to approving the minutes as amended by general consent. President Cindy Hall announced the minutes as written were approved by general consent.

#### Committee to Review the 96th Annual Meeting Minutes

President Cindy Hall indicated the following members have been asked and have agreed to review the minutes of this year's Annual Business Meeting and present them to the AAUW Pennsylvania Board for endorsement and subsequent member ratification: Deb Roney, Huntingdon and Carlisle, and Sally Kalin, State College.

#### **Old Business**

Bylaws Chair Deb Roney reminded those present of the voting procedures of AAUW Pennsylvania. Then, as chair of the Nominating and Elections Committee, she gave the following report:

- "The following are the candidates presented by the Nominating and Elections Committee for the 2025-2027 term.
  - Karen Wellin (Valley Forge), Membership Vice President
  - Charlotte Ridge (Huntingdon), Secretary
  - Pam Fuller (State College), Finance Officer

I will dispense with the reading of the candidate bios, which were provided to members during the election process. Because this meeting is not being held in person, the officer election was completed with online voting, paper ballots, and branch voting. Votes were cast by members from 22 of the 26 AAUW Pennsylvania branches. The Nominating and Elections Committee received 112 votes online, 21 votes from 1 branch voting event, and 3 paper ballots.

Tallies showed 135 votes for Karen Wellin for Membership Vice President, 136 votes for Charlotte Ridge for Secretary, and 135 votes for Pam Fuller for Finance Officer. One write-in vote was cast for the office of membership VP and one for the office of finance officer.

Given that report of the votes cast by online, branch voting events, and paper ballot, I declare the election of candidates Karen Wellin, Charlotte Ridge, Pam Fuller."

#### AAUW Pennsylvania Bylaws Proposals

President Cindy Hall again called on Bylaws Chair Deb Roney to introduce proposed changes to the AAUW Pennsylvania bylaws. All proposed changes to the AAUW Pennsylvania bylaws were approved by the AAUW PA board at their meeting on February 1 and presented to the membership for commentary from February 20 to March 15. The comments were reviewed by the bylaws committee. No changes were necessary, and the final proposals were noticed to the membership on March 31 on the AAUW PA website and on April 1 via email to all members.

On behalf of AAUW PA Bylaws committee, Deb Roney moved both the acceptance of the proposed substantive changes to the bylaws and the acceptance of the proposed technical changes to the bylaws.

President Cindy Hall proposed dispensing with the reading of the proposed amendments. There were no objections. Bylaws Chair Deb Roney announced the results of the online vote (April 1 to April 30, 2025). There were 96 votes cast; including 1 national/state member and 95 members from 20 of the 26 AAUW Pennsylvania branches. *All the proposed bylaws amendments were passed unanimously*.

With the passage of the bylaws changes, Deb Roney announced that "a clean copy of the bylaws with all approved changes made will be provided on the AAUW PA website and emailed to all branch presidents no later than May 15, and a breakdown of the vote by Article will be included in the next *Keystoner*."

#### **New Business**

President Cindy Hall asked those present to declare any new business. Hearing none, she proceeded to the announcements.

#### Announcements

President Cindy Hall shared a few announcements for the good of the order.

- AAUW PA branch awards can be found in the 2024-25 Yearbook, which will be posted on the AAUW Pennsylvania website. President Cindy Hall congratulated all the winners.
- Program Vice President Lori Woods reminded everyone of the dates of the 2025 summer retreat: June 27<sup>th</sup> (evening reception) and June 28<sup>th</sup>. She announced that the retreat would be facilitated by Spud Marshall and feature several storytellers to inspire attendees.
- Membership Vice President Karen Wellin reminded members of the Shape the Future program and noted that Pennsylvania is the fourth largest state for membership this year.
- President Cindy Hall called for volunteers for the AAUW Atlantic Conference and reminded members of AAUW National webinars and elections.
- President Cindy Hall concluded the meeting by encouraging members to donate to AAUW PA, since there will be no dues increase this year at the state level.

#### Adjournment

President Cindy Hall asked if there was any further business, and hearing none, asked for a motion to adjourn the business meeting by acclamation. Bylaws Chair Deb Roney moved the adjournment OR made the motion. Randi Blauth, Easton, seconded, and the business meeting was declared adjourned at 10:42 AM.

## AAUW PA PROPOSED BYLAWS PROPOSALS

#### BYLAWS OF THE AMERICAN ASSOCIATION OF UNIVERSITY WOMEN OF PENNSYLVANIA ARTICLE I. NAME AND GOVERNANCE

**Section 1. Name.** The name of the organization shall be the American Association of University Women (AAUW) Pennsylvania, hereinafter known as the "Affiliate." **Section 2. Affiliate.** AAUW Pennsylvania is an Affiliate of AAUW as defined in Article V.

**Section 3. Legal Compliance.** This Affiliate shall comply with the requirements of AAUW and federal, state, and local law. The bylaws of this Affiliate shall in no way conflict with the AAUW Bylaws and/or policies.

#### ARTICLE II. PURPOSE

**Section 1. Purpose.** As described below in Article V setting out the Affiliate purpose, each Affiliate supports AAUW's purpose which is set forth in the AAUW bylaws as follows:

The general purposes of the Association shall be in accordance with the requirements of the Internal Revenue Code of 1986, as amended, Section 501(c) (3) such that the Association shall be at all times "organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes" as described in the Code and any corresponding provision of any future United States Internal Revenue Law. In service of the purposes set out in the Articles of Incorporation, the Association's specific purpose is to advance equity for women and girls. In keeping with this purpose, AAUW may:

a. promote equity, education, and development of opportunities for women and girls that enable them to realize their full potential;

b. provide fellowships and grants to women and girls;

c. cooperate with other organizations having mutual interests;

d. take such other actions as are permitted to a District of Columbia nonprofit corporation consistent with its purpose, the Articles and these Bylaws.

#### ARTICLE III. USE OF NAME

**Section 1. Policies and Programs.** The policies and programs of AAUW shall be binding on all members and Affiliates engaged in AAUW activities, and no member or Affiliate shall use the name of AAUW to oppose such policies or programs.

**Section 2. Proper Use of Name and Logo.** The name and logos of AAUW and this AAUW Affiliate may be used only by Members and Affiliates only according to policies and procedures established by the AAUW Board of Directors.

**Section 3. Individual Freedom of Speech.** These bylaws governing use of the name of AAUW shall not abridge the freedom of speech of any AAUW member to speak an opinion in the Member's own name except that this Article shall govern whether the Member may identify AAUW in conjunction with that opinion.

#### ARTICLE IV. MEMBERS OF THE ASSOCATION

**Section 1. Membership.** The membership of this Affiliate shall consist of individual AAUW members ("Individual Members") and college/university members ("College/University Members"), as well as other membership categories as determined by AAUW.

#### Section 2. Member Qualification.

a. Individual Members.

(i.) Eligibility. An individual holding an associate (or equivalent, e.g., RN), bachelor's, or higher degree from a higher education institution accredited by a regional accrediting agency recognized by the U.S. Department of Education (an "Accredited Higher Education Institution") or other qualified institution located outside of the United States, as determined by the Board of Directors, shall be eligible to receive admission to AAUW membership; such membership shall be granted upon payment of AAUW dues. The provisions set forth in this section are the sole requirement for eligibility and admissibility to AAUW membership except that the Board of Directors may establish a process to assess credentials that are submitted based on degree equivalence.

(ii.) Saving Clause. No Individual Member shall lose membership due to any change in the status of the higher education institution upon which original qualification for membership was based.

b. College/University Members. Any Accredited Higher Education Institution or other qualified higher educational institutions located outside the United States, as determined by the Board of Directors, that pays annual dues to AAUW shall be eligible to be a College/University Member. Each College/University Member shall appoint one or two representatives who are eligible to be Individual Members and who shall each have the membership benefits of an Individual Member and any other benefits that accrue to representatives of College/University Members, as determined by the Board of Directors.

c. Other Organizational Members. The Board of Directors may set forth criteria for other organizations ("Organizational Members") to join AAUW.

**Section 3. Student Associates.** The AAUW Board of Directors may permit undergraduate students enrolled in Accredited Higher Education Institutions or in other qualified educational institutions located outside the United States, as determined by the AAUW Board of Directors, to associate with AAUW, with fees (if any) and benefits as determined by the AAUW Board of Directors.

#### Section 4. Dues of Members.

a. Amount. The annual dues and member benefits for any category of member shall be established by a two-thirds vote of the AAUW Board of Directors and dues shall be payable in accordance with the procedures established by the Board of Directors.
Members shall be notified at least thirty (30) days in advance of the intent to consider a change in the dues, the proposed amount, and the rationale for the change.
b. Life Membership.

(i.) Paid. An Individual Member may become a life member (a "Life Member") upon a one-time payment of twenty years' annual AAUW national dues, based on the amount of annual AAUW dues set the year the Member elects to become a Life Member, but without credit for AAUW dues paid in prior years. Thereafter, the Life Member shall be exempt from the payment of AAUW national dues.

(ii.) Fifty-Year Honorary. An Individual Member who has paid AAUW dues for 50 years shall become a Life Member and shall thereafter be exempt from the payment of AAUW national dues.

#### Section 5. Membership Decisions.

a. Appeals. Any potential Member that has been refused admission to membership may appeal to the Board of Directors for review. The decision of the Board of Directors shall be final.

b. Removal. Any Member may be suspended or removed from membership for any conduct that tends to injure AAUW or to adversely affect its reputation or that is contrary to or destructive of its purpose according to these Bylaws, with action taken following policies and procedures adopted by the Board of Directors. In addition, a College/University Member that is no longer eligible for membership shall be removed from membership as soon as practicable after it loses its eligibility.

#### **ARTICLE V. AAUW AFFILIATES**

**Section 1.** An AAUW Affiliate has no member status but is an independent local organization (incorporated or not) consisting of AAUW individual members who support AAUW's purpose at a state or local level and which has been given the right to use AAUW's name and has executed, and continues to comply with, the AAUW Affiliate Agreement approved by the AAUW Board and any other requirements established by the Board from time to time. Use of the AAUW name or logo by the AAUW Affiliate is subject to the Affiliate Agreement and approval of the AAUW Board of Directors.

#### Section 2. Organization.

a. Purpose. Affiliates shall promote the purposes, programs, and policies of AAUW. b. Bylaws. As an AAUW Affiliate, this Affiliate shall develop bylaws as meet this Affiliates'

needs. However, any such bylaws shall not conflict with AAUW Bylaws, policies, or with applicable law. In the event of a conflict, the AAUW Bylaws shall prevail over this Affiliate's bylaws unless the specific provision of the AAUW Bylaws is not permitted according to this Affiliate's state statutes, in which case the Bylaws shall be construed as closely as possible to the original intent of the AAUW Bylaws as permitted by state laws.

c. Structure. As an AAUW Affiliate, this Affiliate may create such leadership structures as meet this Affiliate's needs. This Affiliate shall provide AAUW with designated contacts for administration and finance.

#### Section 3. Loss of Recognition of an Affiliate.

a. The AAUW affiliation status of any Affiliate may be revoked for cause through affiliation review procedures specified by the AAUW Board of Directors.

b. Any Affiliate shall have the right to appeal to the AAUW Board of Directors within a designated period.

**Section 4. Property and Assets.** The title to all property, funds, and assets of this Affiliate is vested in the Affiliate. As an AAUW Affiliate, this Affiliate shall have complete control of its property and assets, except that such property and assets shall not be used for any purpose contrary to AAUW's purposes. In the event of the dissolution of this Affiliate or the termination of this Affiliate's affiliation with AAUW, all assets of this Affiliate shall be transferred and delivered to AAUW or to another Affiliate designated by AAUW. AAUW may solicit and consider recommendations from local leaders before making a designation.

#### **ARTICLE VI. PARLIAMENTARY AUTHORITY**

The rules contained in the most current edition of *Robert's Rules of Order Newly Revised* shall govern this Affiliate in all instances in which they are applicable and in which they are not inconsistent with this AAUW Affiliate Bylaws or with the requirements of AAUW or applicable laws.

#### ARTICLE VII. AAUW-MANDATED AMENDMENTS TO THE BYLAWS

AAUW-mandated amendments shall be implemented by this Affiliate's board of directors

without a vote of the Affiliate's membership and as prescribed by the AAUW Board of Directors.

#### ARTICLE VIII. AFFILIATE AMENDMENTS TO THE BYLAWS

Section 1. Amendments Not Mandated by AAUW. Provisions of these bylaws not governed by the bylaws of AAUW may be amended at the Affiliate annual business meeting by a two-thirds vote of those voting. Written notice of the proposed bylaws amendments shall have been sent to members no fewer than ten but no more than sixty days prior to the meeting. If the previous notice has not been given, these bylaws may be amended by unanimous vote of those voting at the Affiliate annual business meeting. Section 2. Member Input. The board shall establish procedures to provide for member input before the vote.

**Section 3. Branch Compliance.** An amendment to the bylaws of the Affiliate shall become effective and binding on all branches within the Affiliate.

**Section 4. Final Approval.** The Bylaws of the Affiliate and all subsequent amendments thereto shall be forwarded to the chair of the AAUW Governance Committee for approval.

#### **ARTICLE IX. AFFILIATE MEMBERSHIP AND DUES**

**Section 1. Affiliate Members.** All members of local AAUW affiliates located in Pennsylvania, hereinafter known as branches, are also members of the Affiliate. An AAUW national member may become a member of the Affiliate upon payment of Affiliate dues.

#### Section 2. Dues.

a. Affiliate Dues. Annual Affiliate dues for all categories of members shall be determined by a two-thirds vote of those present and voting at the Affiliate Annual Business Meeting, provided that notice has been given to all members as specified in Article XVI.3.

b. AAUW Paid Life Members. AAUW Paid Life Members who are members of the Affiliate are required to pay annual Affiliate dues.

c. AAUW Fifty-Year Honorary Life Members. AAUW Fifty-Year Honorary Life Members who are members of the Affiliate are exempt from the payment of Affiliate dues.

d. AAUW College/University (C/U) Representatives. AAUW C/U Representatives who are members of the Affiliate are required to pay Affiliate dues. Branches may choose whether or not to charge branch dues to C/U representatives.

e. Benefits of Membership. Payment of Affiliate dues entitles members to the membership benefits as determined by the Affiliate Board of Directors.

**Section 3. Payment.** Any member whose annual Affiliate dues remain unpaid 45 days after the expiration of their membership shall be dropped from Affiliate membership. a. Reciprocity. A current paid member of a branch or comparable AAUW-affiliated entity

may transfer membership to another branch or comparable AAUW-affiliated entity without payment of additional dues.

b. New Members. New members may join the Affiliate at any time. Affiliate dues are payable upon joining.

# ARTICLE X. AFFILIATE NOMINATIONS AND ELECTIONS Section 1. Nominations.

a. There shall be a nominating and elections committee composed of a chair from the Affiliate board appointed by the president plus a representative from each district in the Affiliate.

b. Individual members or branches may nominate a candidate for election provided they acquire the written consent of the candidate and forward the information on the form provided to the nominating and elections committee by the designated due date.

c. The nominating and elections committee shall present a slate of nominees to the membership at least one month prior to the Affiliate annual business meeting.d. If no candidate is identified for an office in time to be included on the ballot, the executive committee will appoint someone at the first meeting of the newly elected board.

#### Section 2. Elections.

a. All elections shall be held annually. All elections shall be conducted under the oversight of the nominating and elections committee.

b. All members are encouraged to vote in all elections of the Affiliate. The board of directors shall determine the method(s) of voting and voting period in compliance with PA law and notify members.

c. Officers shall be elected by a plurality vote.

#### **ARTICLE XI. AFFILIATE OFFICERS**

**Section 1. Affiliate Officers.** The Affiliate shall have a minimum of three separate officers: one responsible for the management of the Affiliate, one responsible for financial affairs, and one responsible for recording and making available upon request the minutes of each noticed Affiliate or multi-Affiliate meeting and board meeting.

a. The elected officers or co-officers shall be president, program vice president, membership vice president, marketing and communications vice president, secretary, and finance officer.

b. The appointed officers shall include officers fulfilling the functions of administrative director and public policy and such other functions as deemed necessary by the Affiliate board of directors.

c. The above-mentioned elected and appointed officers shall be members of AAUW and the Affiliate and shall have qualifications necessary to execute the duties of the respective offices.

d. Officers shall serve for a term of two year(s) or until their successors have been elected or appointed and assume office. The term of each officer shall begin on July 1.

e. No elected officer shall hold more than one office at a time, and no officer except the administrative director shall be eligible to serve more than two consecutive terms in the same office. No officer with the exception of the president and the administrative director shall be eligible to serve on the board for more than eight consecutive years.

f. The incoming president may call a meeting of the incoming officers prior to July 1. g. All vacancies in office except that of president shall be filled for the unexpired term by the executive committee. Any officer so appointed shall hold office until the next Affiliate annual business meeting, at which time the unexpired terms, if any, shall be filled by election. A vacancy in the office of president shall be filled by the following method: the program vice president shall move to the presidency.

h. The president, program vice president, and marketing and communications vice president shall be elected in even-number years. The membership vice president, secretary, and finance officer shall be elected in odd-numbered years.

#### Section 2. Affiliate Officer Duties.

a. Affiliate officers shall perform the duties prescribed by these bylaws, by the rules of procedure and policy adopted by the board of directors, by the current edition of *Robert's Rules of Order Newly Revised*, and by the Affiliate policy manual. The elected and appointed directors shall facilitate and promote the purpose and mission of AAUW.

b. The president shall be the official spokesperson and representative for the Affiliate, shall be responsible for submitting such reports and forms as required by AAUW, and shall be the designated contact from the Affiliate to AAUW.

c. The vice presidents shall perform such duties as the president and board shall direct.

d. The secretary shall record and keep minutes of all business, board, and special meetings and is the member designated to record and make available upon request the minutes of each meeting and board meeting. The secretary shall perform such other duties as the president and board shall direct.

e. The finance officer shall be responsible for collecting, distributing, and accounting for the funds of the Affiliate and for meeting specific deadlines. The finance officer shall serve as custodian of all funds and securities and as the designated contact for finance to AAUW.

f. Appointed officers shall perform such duties as the president and board shall direct. g. The public policy chair(s) and public policy committee in consultation with the president shall determine whether any particular state matter is one on which the Affiliate has a policy and whether any particular action is in accord with the Affiliate policies and principles. No action in the name of the Affiliate shall be taken on any matter until such determination has been made. Should either the chair or the president so request, a matter may be referred to the Affiliate board of directors for final determination.

h. All elected officers shall submit an annual written report to the president, board of directors, and members at the end of the fiscal year.

#### **ARTICLE XII. AFFILIATE BOARD OF DIRECTORS**

**Section 1. Composition.** The board of directors shall include the elected and appointed officers of the Affiliate.

#### Section 2. Administrative Responsibilities.

a. The board shall have the general power to administer the affairs of the Affiliate and to initiate and carry out its programs and policies.

b. The board may adopt rules to govern its proceedings.

c. The board shall have fiscal responsibilities as outlined by Article XV.2.

d. It shall approve the programs for Affiliate meetings.

e. It shall approve the establishment of special committees, working groups, and task forces.

**Section 3. Branch Recommendations.** The board shall recommend to AAUW action to be taken in regard to the admittance of new branches or the discontinuance of current branches.

**Section 4. Meetings.** Meetings of the board shall be held at least two times per year. All

meetings of the board of directors shall be open and may be attended by any member of the Affiliate.

Section 5. Special Meetings. Special meetings may be called by the president and shall be called upon written request of five board members, provided that at least five days' notice of such meeting and its agenda have been given to the board members. Section 6. Quorum. The quorum for a meeting of the board shall be a majority of the voting members. Co-officers shall be considered as one voting member of the board. Section 7. Voting Between Meetings. Between meetings of the Affiliate board, a vote may be taken at the request of the president on any question submitted in writing, by conference call, or by any electronic means to all members of the board. Board members shall send their vote to the secretary. If the secretary is unavailable, the president may select an alternate member of the board, such as the administrative director, who did not put forth the motion to receive and record the votes. The deadline for responses shall be ten days after the question has been submitted; voting will close early if all votes have been cast. If a majority shall vote on a question, the vote shall be counted and shall have the same effect as if cast at a meeting of the board. The secretary or the designated alternate shall immediately notify all board members of the result and will report the motion and the result of the vote at the next board meeting. Section 8. Delegation of Authority. The board may delegate such authority as it

deems necessary to the executive committee.

**Section 9. Removal from Office.** A member of the board of directors may be removed for any reason by a two-thirds vote of the board in accordance with policies and procedures adopted by AAUW and the Affiliate.

#### ARTICLE XIII. AFFILIATE EXECUTIVE COMMITTEE

**Section 1. Composition.** The executive committee shall be composed of the elected officers. The administrative director shall be a non-voting member of the committee. **Section 2. Duties.** The executive committee may act for the board of directors between board meetings and shall have such power and duties as may be delegated to it by the board. The executive committee shall:

a. Make recommendations to the board of directors.

b. Report to the board of directors at their next meeting on all activities and actions taken.

c. Fill a vacancy in any office except that of the president.

d. Accept and request resignations of board members.

**Section 3. Meetings.** The executive committee shall meet at the call of the president and at other times at the written request of two members of the committee, provided that the agenda and notice of the meeting have been given to the members at least five days in advance.

**Section 4. Quorum.** The quorum shall be a majority of the voting members of the executive committee. Co-officers shall be considered as one voting member of the executive committee.

**Section 5. Voting Between Meetings.** Between meetings of the executive committee, a vote may be taken at the request of the president on any question submitted in writing, by conference call, or by any electronic means to all members of the executive committee. Executive committee members shall send their vote to the secretary. If the secretary is unavailable, the president may select an alternate member of the executive committee, such as the administrative director, who did not put forth the motion to receive and record the votes. The deadline for responses shall be five days after the question has been submitted; voting will close early if all votes have been cast. If a majority shall vote on a question, the vote shall be counted and shall have the same effect as if cast at a meeting of the executive committee. The secretary or the designated alternate shall immediately notify all executive committee members of the result and will report the motion and the result of the vote at the next board meeting. **ARTICLE XIV. AFFILIATE COMMITTEES** 

# **Section 1. Establishing Committees.** The president may establish standing and special committees as needed with consent of the board.

**Section 2. Composition.** Committee chairs shall be members of AAUW and the Affiliate and shall be appointed by the president and confirmed by the Affiliate board of directors. Committee chairs may serve on the Affiliate board of directors as determined by the president and confirmed by the board at the time of appointment and confirmation.

#### Section 3. Purpose.

a. With the approval of the board, each committee shall formulate programs and activities to carry forward the mission of AAUW within the Affiliate.

b. When required by the board of directors, the chair of each committee shall report to the Affiliate president.

#### ARTICLE XV. FINANCIAL ADMINISTRATION

**Section 1.** The fiscal year shall correspond with that of AAUW and shall begin on July 1.

**Section 2. Financial Policies.** The Affiliate shall set and maintain policies and procedures to control financial records consistent with generally accepted accounting principles and federal, state, and local laws, including an annual financial review.

#### ARTICLE XVI. MEETINGS OF THE AFFILIATE MEMBERSHIP

#### Section 1. Annual Meeting.

a. The Affiliate shall hold an annual business meeting. The exact date, time, and place of the Affiliate annual business meeting shall be determined by the board of directors. b. The purpose of the annual business meeting shall be to conduct the business of the Affiliate. Such business shall include the official election of officers, receipt of written reports on the activities and financial condition of the Affiliate, and transaction of such other business as may properly come before the meeting. Such other business may include the adoption of or amendments to the public policy priorities, resolutions, changes to the Affiliate dues structure, and amendments to these bylaws.

**Section 2. Special Meetings.** Special meetings may be called by the president or shall be called by the president on the written request of two-thirds of the members of the board of directors or two-thirds of the members of the Affiliate.

**Section 3. Meeting Notice.** Notice of meetings shall be sent to all members of the Affiliate at least 30 days prior to any Affiliate meeting.

#### Section 4. New Business for the Affiliate.

a. New business may be brought before the membership at the annual meeting by a motion or resolution from any two Affiliate members or any branch if it is first submitted to the Affiliate president ten days before the date of the winter board meeting for consideration by the board.

b. The board shall establish procedures to provide for member input before the vote at the annual meeting.

**Section 5. Quorum.** The quorum shall be five percent of the Affiliate membership as of the official notice of the meeting.

#### Section 6. Voting.

a. Each member of the Affiliate in good standing as of the official notice of the meeting is entitled to one vote at any annual or special meeting of members. For purposes of the quorum, Affiliate members who cast a vote by any approved means are considered to be present at the meeting.

There shall be no proxy voting.

c. The affirmative vote of a majority of the votes cast shall be necessary for the adoption of noticed business, except that a two-thirds vote shall be required to adopt amendments to these Bylaws and changes to the Affiliate dues structure.

d. The board of directors shall determine the method(s) of voting and voting period in compliance with PA law. The system and policies to be used for the conduct of the vote, including methods by which every Affiliate member's input is sought prior to the submission of a proposal for final adoption, shall be adopted by a two-thirds vote of the board of directors and shall be made available to the Affiliate members.

**Section 7**. **Meeting Rules.** Affiliate annual business meeting rules shall be proposed by the Affiliate board of directors and considered by each Affiliate annual business meeting as its first order of business.

Section 8. Special Circumstances. If circumstances prevent the holding of an Affiliate meeting, the board of directors shall provide for the conduct of necessary business. ARTICLE XVII. AFFILIATE INDEMNIFICATION

Every board or committee member may be indemnified by the Affiliate against all expenses and liabilities, including counsel fees, reasonably incurred or imposed upon such members of the board or committee in connection with any threatened, pending, or completed action, suit, or proceeding in which the board or committee member may become involved by reason of being or having been a member of the Affiliate, or any settlement thereof, unless adjudged therein to be liable for negligence or misconduct in the performance of duties. In the event of a settlement, the indemnification herein shall apply only when the Affiliate board approves such settlement and reimbursement as being in the best interest of the Affiliate. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which the member of the board or committee is entitled.
