

MESSAGE FROM THE PRESIDENT



In State College, college students are back in class and school buses are once again on the roads. Usually, I welcome the change of pace and begin September renewed and ready to tackle a busy calendar and To Do list. However, this year feels different since much of what I believe in has either collapsed or faces a targeted demise. The relentless attacks on higher ed have been vicious and lacking purpose. Critical research studies losing funding, students finding themselves in limbo about their financial aid packages, DE&I activities and structures under extreme duress, and institutions held hostage as they stand for their ideals and the critical work they perform. The funding decisions made by this Administration will have lasting effects well into the future, impacting generations to come.

While there has been little time to reenergize ourselves these past few months, we must continue the work of AAUW locally and across our state. Others are counting on us to stand. Many branches have carried our banner. Sandra Miller, state Public Policy Chair, and I as well as others on the state board are fortunate to hear how you are continuing to stand for women, girls, and all Americans. Daily, I am overwhelmed at the tenacity of our members.

As I enter my fourth and last year as President of AAUW Pennsylvania, I am very aware of the many talented and energetic members in our state. We will need strong passionate leaders to carry us through these years. Late this month or early in October, you will be able to book your room in the reserved room block at the early bird discount. We need AAUW PA members to show up in force, particularly since we are the host state. I hope very much to see every branch represented.



PUBLIC POLICY UPDATES



It has been a hectic summer, and there is so much to cover. We will start with National AAUW resources. AAUW National is very busy doing the hard work in Washington, D.C., pursuing our priorities. They have compiled a listing of actions they have taken, bills they endorsed, and coalitions that they are supporting. Below you will find links outlining their work so far this year. Please take the time to review their work and support it where you can. They are a small but mighty team doing hero's work for our organization.

State Updates:

No Budget! As of August 25th, there is still no budget in Pennsylvania. Our 1.7 million school children are starting school where over \$1.4 billion in state payments have not arrived. Follow EdVoters for the latest budget news as we wait for the General Assembly and the Governor to negotiate how to pay for mass transit and education funding that meets the needs of all our citizens. Not having a budget means local libraries, social services, childcare centers, and so much more are not receiving the funds they need to provide the services that we all use throughout the state. We will keep you posted on any actions that we recommend in the coming weeks.

While we wait for the budget, there are actions we can take on other legislative priorities.

Advocacy Day with Partners from Campaign for Women's Health: Nov 18th

AAUW is joining our partners from the Campaign for Women's Health in hosting an Advocacy Day in Harrisburg on November 18th.

The goals of this day would be:

- Make it clear what our legislative priorities are in the House and Senate
- Show the force of our campaign through the collaboration of our partners and their supporters showing up in the Capitol
- Host a "rage room" where supporters can directly advocate for your legislative priorities
- Legislative meetings connecting org leaders and advocates with elected officials

We will provide all the messaging and support you will need in meetings with our lawmakers. We will have a listing of bills that we are endorsing, materials to drop off at offices, and signs to hold for any press events. We hope to schedule at least one opportunity on the steps to share our stories and demands for action with invitations to our state leaders to join us.

In case you are wondering (I did), what is a "rage room"? It is a place where advocates can gather to write postcards, make art and videos, and find various ways to express their views on the legislative situations facing us. Fun activities are planned, and I look forward to my first rage room.

The registration link has not been released yet, but once it is available, it will be shared with all branches. Until then, mark your calendars: Tuesday, November 18th! See you there.

ELECTION RESULTS

In the 2025 election of the Membership Vice President, Finance Officer, and Secretary held in April 2025 using online balloting, branch balloting, and mail-in ballots, 136 AAUW PA members cast ballots. Karen Wellin received 135 votes for Membership Vice President; there was also one write-in vote. Charlotte Ridge received 136 votes for Secretary. Pam Fuller received 135 votes for Finance Officer; there was also one write-in vote. These three officers were installed at the June 27 board meeting in Boalsburg, PA. NOMINATING AND ELECTIONS COMMITTEE—VOLUNTEER NEEDED

AAUW PA is seeking a volunteer to serve on the Nominating and Elections Committee. Other than the co-chairs, both committee members and alternates cannot be serving on the state board at the time of service on the nominating committee. We still need a representative from the Western district.

The committee's job is to identify and vet candidates for the three offices up for election in spring 2026 for the 2026-28 term of office: AAUW PA President, Program Vice President, and Marketing and Communications Vice President. The job is small and is done via email or Zoom meetings outside of work hours. Ideally, most of the work will be completed by January.

Alternates are included on all email communications of the committee so that if a member is unable to continue in the position or is nominated for one of the offices, the alternate can take over. Alternates do not need to attend meetings unless the member from that district is unable to serve.

CALL FOR NOMINATIONS

AAUW PA is seeking nominations for the following officers to fill 2026-2028 term on the State Board.

President: The president is responsible for directing, coordinating, and overseeing the work of the state and for remaining in close contact with PA branches. In addition, the president serves as the primary liaison with National AAUW. Although the 2026 regional conference will be held during the incoming president's term, it will have already been planned ahead of the term. The incoming officer will assist with the regional conference as needed.

Program Vice President: The program vice president is responsible for planning the biennial convention program in 2028 and the program for the biennial summer retreat in 2027 and for planning, coordinating, implementing, and reporting other mission-based programming and such other duties as the president and board shall direct. Although the 2026 regional conference will be held during the incoming program vice president's term, it will have already been planned ahead of the term. The incoming officer will assist with the regional conference as needed.

Marketing and Communications Vice President: The Marketing and Communications Vice President works closely with the board to develop strategy and manage state communications to members and the public, to ensure that the brand image is consistently upheld, and to enhance visibility across the state and for such other duties as the president and board shall direct. In addition, the position serves as the editor of the *Keystoner* newsletter and the annual yearbook. Although the 2026 regional conference will be held during the incoming marketing and communications vice president's term, it will already have a marketing team. The incoming officer will assist with the regional conference as needed.

Meeting Obligations: The state board meets four times annually, usually in July, October, January, and April or May (in even-numbered years, just before the State Conference). The January meeting is typically held on Zoom. Other meetings are expected to be in person but may be virtual.

Board expenses related to the position and most expenses for attendance at in-person meetings, when they are held, are reimbursed by AAUW-PA.

BYLAWS UPDATE

National Bylaws

As you may recall, there was a national vote to amend the national bylaws in the spring. The new national bylaws can be accessed here: https://www.aauw.org/app/uploads/2025/05/2025-AAUW-Bylaws.pdf. None of the recent changes made require changes to branch bylaws.

Details of the AAUW PA Bylaws Balloting in April:

The outcome of the bylaws balloting on the proposed substantive and technical amendments done in April 2025 ahead of the May 3 state annual business meeting follows. The previous bylaws, under which this balloting took place, established the quorum as 81 members, so the quorum was attained and the vote counted. There were 96 votes cast, including one national/state member and 95 members from 20 of the 25 AAUW Pennsylvania branches. **All the proposed bylaws amendments were passed unanimously. The 2025 bylaws can be accessed** here.

Thank you to ALL 24 PA branches that have already made the mandated bylaws updates. If any branch is working on other bylaws changes, <u>Bylaws Chair Deb Roney</u> stands by ready to assist.

Two things to keep in mind for bylaws changes not mandated by AAUW National:

- All branch bylaw amendments must be approved by the state bylaws committee before the required branch vote.
- Although AAUW requires only an administrator and a finance officer for a branch to exist, PA state statutes require every non-profit organization to have a secretary. According to state law, the same person may hold multiple offices. AAUW Carlisle created the Trailblazer Award in 2019 to recognize girls who are interested in vocational or technical pathways in high school but may not otherwise receive positive support or recognition. This year's Trailblazers studied in the fields of automotive technology, carpentry, communications, culinary arts, engineering, health, marketing, and workforce development.



Trailblazer honorees are selected by their CTE (Career and Technical Education) teachers based on good citizenship at school, enthusiasm for their CTE program, and GPA.



The 14 honorees were introduced by members of the Trailblazer Committee: Barb Attivo, Gail D'Urso, Mary France, and Lillian Wong. Committee member Carolyn Freberg was unable to attend. Each honoree was presented with a Trailblazer Certificate and a stadium blanket embroidered with *Trailblazer* and the AAUW Carlisle branch logo. A special \$500 award, initiated last year as part of the 100th anniversary, was awarded to one honoree at the Career and Technical Education Awards night.

The event program featured a panel of local women who have also pursued non-traditional careers who shared their experiences and offered helpful advice to the girls as they set out on their careers.

The CLA committee was impressed with her academic accomplishments and her commitment to help other female students once she's established in her career. Yvonne plans to use the funds to purchase the professional equipment that court reporters are expected to finance themselves.

The Legacy of Sophie Masloff

Dr. Barbara Burstin, author of *Sophie: The Incomparable Mayor Masloff* will present "The Legacy of Sophie Masloff" on Tuesday, September 9, 2025 at 10:00 am at the Cooper-Siegel Community Library.

As the first woman to hold the job of Mayor of Pittsburgh, as well as the first Jewish mayor, Sophie Masloff was an unlikely leader, but one of Pittsburgh's most memorable. By the end of her tenure in 1994, she was also one of the city's most high-profile mayors.

Sophie lived and breathed Pittsburgh, her beloved hometown. Join us as Dr. Burstin recounts Mayor Masloff's humble beginnings and her improbable journey to the highest office on Grant Street.

Barbara Burstin is an Adjunct Professor in the history department at the University of Pittsburgh, specializing in U.S. history, Jews in the U.S., and the Holocaust. She earned her doctorate degree from Pitt. Dr. Burstin has authored several award-winning books on the Jewish experience in Pittsburgh, including Steel City Jews: A History of Pittsburgh and Its Jewish Community.

Success Stories: Gwen's Girls

Dr. Maureen Anderson, Director of Education, Gwen's Girls will present "Success Stories: Gwen's Girls" on Tuesday, October 14, 2025 at 10:00 am at the Faith United Methodist Church (261 West Chapel Ridge Road, Fox Chapel)

Gwen's Girls is a Pittsburgh nonprofit organization with a powerful mission: helping at-risk girls and young women overcome emotional and socio-economic challenges on their path to becoming successful, self-sufficient adults. Brighter futures at Gwen's Girls begin with educational support; holistic, gender-specific programs that enhance self esteem; and social services designed to promote and strengthen mental health. Our speaker, Maureen Anderson, will focus on the organization's initiatives that improve educational outcomes and workforce readiness.

Gwen's Girls grew from the vision of Gwen Elliott, a Black woman who shattered barriers by becoming one of Pittsburgh's first African-American police officers and eventually commander of Pittsburgh's police force. During her tenure, she witnessed first-hand the struggles of young women and girls growing up in Pittsburgh's low-income neighborhoods. Gwen's Girls was the result of her determination to help them attain what she herself had achieved: respect from their community and a better quality of life.

Dr. Maureen Anderson has been the Director of Education at Gwen's Girls since 2023. She brings diverse perspectives to her role, having prior professional experience in government, business, education, and nonprofits. She taught Career Readiness and Workforce Skills at City Charter High School and computer science at the Community College of Beaver County. Dr. Anderson is also a valued guest speaker for Global Pittsburgh. With a doctorate in education from Point Park University, Maureen is a Certified Education Administrator for grades K – 12 in Pennsylvania.

AAUW State College: 2025 Used Book Sale Brings Record Turnout

This May's AAUW State College Used Book Sale, a fixture in State College since 1962, brought out nearly 7,700 shoppers, a record turnout and an increase of 4.5% over last year. Mary Ann Blair, Used Book Sale Co-Chair, commented, "The increased attendance at this year's sale tells us that readers still seek out paper books. I have seen that smile of discovery as someone spots a particular title or author. Our generous community supplies the books and our volunteers and community partners continue to make the sale a treasured event. "

After expenses, the cost of renting the book workshop throughout the year and putting on the sale - the branch will net about \$161,000 for local programs of non-profits that empower girls and women in areas such as STEM, health, literacy, and economic self-sufficiency. In addition, sponsorships are awarded for college women to attend a multi-day leadership conference and to supplement a branch scholarship endowment for returning adult women students. Additional monies fund mission-based Branch programs and priorities, and operations.
