# From National Public Policy Staff: Federal — What to know now

• Pay gap widens (again). For the second year in a row, the gap grew. Not great! But it's also a neon sign for action. Read AAUW's <u>press release</u> on the initial data. What's next? We're updating The Simple Truth with state data, preparing resources that can be used for presentation in the community, in your branches, or at state conventions. We'll be releasing this with the 2026 Equal Pay Day calendar in Dec/Jan.

- **Supreme Court:** The Court is not impacted by the shutdown. <u>Here's a rundown</u> of the cases we're keeping an eye on.
  - There was a rally for voting rights at the Supreme Court on Oct. 15<sup>th</sup>. Gloria L. Blackwell
    was among the speakers at the rally. Make sure to check out our social media posts that
    day!
- ERA Congress, community, courts
  - **Congress:** H.J.Res. 80 is at 213 cosponsors; S.J.Res. 38 has 4 (added in bipartisan pairs to demonstrate that equality isn't a partisan issue).
  - Community: ERA Coalition's *It's Our Era: Claim the 28th Amendment* campaign is rolling. You can find their toolkit here.
  - Courts: Equal Means Equal v. Trump (Selective Service challenge) has a motion-to-dismiss hearing pushed to Nov 2025. AAUW did not join the Aug 1 Amicus Brief; we'll keep you posted.

# **HOW JUDICIAL ELECTIONS WORK**

Judges have run in political parties in Pennsylvania ever since the Constitutional Convention of 1967-68. We are one of only seven states to elect judges. An attempt was made in the Convention to establish a merit selection appointment process, but as the current budget impasse proves yet again, Pennsylvania politics have not reached the point where a merit process would be workable. The current system of elections followed by retentions was created as a compromise.

Parties should put forward their best candidates, but once elected, these judges are expected to renounce politics. They may not attend any political events until they stand for retention 10 years later. Retention is supposed to be a nonpartisan performance review; if a judge has not misbehaved, the theory is that the judge should be retained for another 10-year term.

The neutral arbiter of judicial qualifications is the Pennsylvania Bar Association. The Bar represents all lawyers regardless of their political leanings, so it has a clear interest in qualifications and fairness. The Bar interviews and rates candidates, and then publishes its findings. Here are the links to those reviews so you can see for yourself why they gave the rating that we report below.

#### **CANDIDATES FOR VACANCIES**

We have one opening each on the Supreme Court and the Commonwealth Court.

These candidates will be at the top of your ballot in the usual fashion, where political party is indicated.

Superior Court hears appeals from county counts, most often involving family law and other issues between individuals. For Superior Court, you will see three candidates.

- **Judge Brandon Neuman** is a Democrat who is rated Highly Recommended by the Bar.
- Maria Battista is a Republican who was a former Assistant District Attorney and was a staff lawyer in government. She is rated Not Recommended by the Bar for failure to participate in their review process. In this year's primary, she upset the Republican party's endorsed candidate, Ann Marie Wheatcraft, who was Highly Recommended by the Bar.
- Daniel Wassmer is currently listed as a member of the Liberal party but has previously run for the Keystone party and the Libertarians. He is a perpetual candidate, having come in fifth behind Sen. Fetterman in 2022 with 0.5% of the vote, and third in 2020 behind then Attorney General Shapiro, getting 1.8%.

Commonwealth Court hears appeals from county courts involving individuals v. governmental units and is the original court of jurisdiction for issues like election law, education, and the environment.

- **Judge Stella Tsai**, a Democrat, is Highly Recommended by the Bar. She is a Judge of Common Pleas currently.
- **Matt Wolford**, a Republican, is an environmental lawyer. He is Highly Recommended by the Bar.

## JUDGES STANDING FOR RETENTION

Please be sure to turn your ballot over because that is where the retention election is. This placement—as far from the competitive elections as possible while still being on the same piece of paper—is meant to underscore that retentions are not supposed to be political.

You will see a series of questions: Shall Judge So-and-so be retained for an additional term on the Court of Whichever? Yes or no. The first three are Justices of the Supreme Court, then Superior, then Commonwealth. Each of these judges is Recommended for Retention by the Bar Association. Their evaluations are included with the candidates for each of the relevant Courts.

You may have gotten mailers or otherwise have seen messaging urging a No vote. That messaging is coming from a billionaire who opposes AAUW's public policy. He is the one who makes the profits on cyber charter schools.

#### **COUNTY LEVEL ELECTIONS**

Across the state, 69 county level judges are up for retention. Because they have served at least one 10 year term—and some have served more—their political party is irrelevant and any issues regarding bad judgement or misbehavior should have come to light in their counties. We know of only one whose performance is questioned. That judge serves in Philadelphia, where the Inquirer has published stories that would be of interest to members in Philadelphia County.

Combined with those on the state level, the serving judges bring a wealth of experience. If they are not retained, the court system essentially will freeze for two years while replacements are elected. Those replacements would lack the experience needed for sound judgement in complex legal matters. Please share this information.

## A NEW FOCUS ON AAUW PA DONATIONS AND NAMED GIFT HONOREES

Launched in 1998, this annual event brings together middle-school girls from several nearby school districts for a full day of mentorship, leadership development, and open conversation. Led by Juniata's AAUW Student Chapter, the Summit pairs each participant with a college mentor and guides them through engaging workshops on self-esteem, body image, mental health, healthy relationships, and women's participation in STEM.

The Sister-to-Sister Summit continues to create lasting connections between students and the broader community, embodying AAUW's mission of advancing equity for women and girls through education, advocacy, and leadership. This year's Mini-Grant will help the Juniata team expand their program, strengthen local partnerships, and develop new hands-on activities that promote confidence and belonging among young women.

The review committee praised the project for its outstanding alignment with AAUW's mission and its strong collaboration with local schools, women-owned businesses, and campus offices, making it a model initiative for other colleges across Pennsylvania. AAUW Pennsylvania celebrates Juniata College's dedication to fostering confidence, collaboration, and empowerment among young women and looks forward to watching this impactful program continue to grow.

## **AAUW Beaver Valley**



The AAUW Beaver Valley Branch hosted its 24th Annual Kitchen Tour and Tasting on October 4, 2025. As in previous years, four local homeowners graciously opened their homes to guests, offering tours of their newly designed or recently renovated kitchens. Each kitchen featured a local chef who prepared a tasting sample of their specialty dish, adding a delicious highlight to the day.

An additional fundraising component of the Kitchen Tour is the Marketplace, held this year in the newly completed International Brotherhood of Electrical Workers (IBEW) Union Hall in Vanport. The Marketplace featured a basket raffle, baked goods, accessories for sale, and vendor displays. It also provided an ideal setting to meet visiting patrons, share the AAUW mission, and offer membership information in a welcoming, one-on-one setting.





We are pleased to report that this year over 340 tickets were sold, with \$15,000 raised to benefit scholarships. #### **AAUW Carlisle**



AAUW Carlisle, in conjunction with the Dickinson College AAUW Student Organization, hosted a panel discussion on the upcoming PA Supreme Court Judicial Retention Election. The event, "Big Money, Big Questions: The Future of PA's Supreme Court," was held Thursday, October 16.

Dr. Sarah Niebler, Associate Professor of Political Science at Dickinson, served as moderator. We had a stellar panel of judicial experts including, Gary S. Gildin, Emeritus Dean, Professor of Law, Penn State Dickinson Law; Hon. Robert A. Graci, former PA Superior Court Judge and former Chief Counsel, PA Judicial Conduct Board; Jane Rigler, Professor of Law, emerita, Penn State Dickinson Law; and Ed Mahon, Investigative Reporter, Spotlight PA.



Dickinson Votes, a campus non-partisan voter engagement organization, was there to assist students wishing to change their out-of-state voter registration to PA.

Living in Liberty: Combatting Sex Trafficking

Elizabeth Echevarria, CEO of Living in Liberty, a non-profit organization that works to combat human trafficking in Southwestern PA by supporting survivors on the streets and in their safe home as well as providing community education about the realities of commercial sexual exploitation will present "Living in Liberty: Combatting Sex Trafficking" on Tuesday, November 11 2025 at 10:00 am at the Faith United Methodist Church (261 West Chapel Ridge Road, Fox Chapel)

Human trafficking is a business enterprise so far below the radar that many Southwestern Pennsylvania residents could live an entire lifetime here without ever detecting its presence. But it's here – on city streets and in dark corners of our communities. It's extremely secretive, making it very difficult to expose and combat. And its perpetrators want to keep it that way.

Enter Living in Liberty, a nonprofit organization dedicated to restoring personal dignity and healing to victims of commercial sexual exploitation. Living in Liberty cannot prevent the crimes from happening, but they *can* sometimes help the women who have survived the ordeal to reclaim their lives and live in freedom again. Liberty Home, a safe house, awaits those who make it. A 5-step program for renewal guides victims from the most basic step – reestablishing their identity – to the final step of emotional and financial independence.

Our speaker, Elizabeth Echevarria, founded Living in Liberty in 2012, after learning about the devasting conditions of human trafficking from an Indian woman from Calcutta. Ms. Echevarria completed ministry training at Reach Northeast Ministry School in 2010 and received her master's degree in social work from Slippery Rock University last year. She will talk about Living in Liberty's mission and discuss the methods they deploy to find and help the women they strive to serve.

#### **AAUW Johnstown**

"Do You Know Your Rights?"



On October 2, 2025, the Johnstown Branch AAUW's Public Policy Committee held a free, open-to-the public presentation concerning the rights afforded to people in the United States by the U.S. Constitution. The program was held from 6-8 PM at the Pennsylvania Highlands Community College.

ACLU Attorney, Ali Szemanski, presented information about the First Amendment and Voting Rights. Attorney Mark Wheeler from the Indiana County Public Defender's Office discussed Fourth and Fifth Amendment Rights. Some of the topics included: the right to assemble, due process, voting, freedom of speech through symbolism, interactions with the law, illegal search and seizure and search warrant. Member and audience questions were answered by the speakers.

Our annual Montgomery Township Autumn Festival is a family-friendly fall celebration featuring food, live music, pumpkin games and decoration, a petting zoo, crafts, K9 demonstration, hayrides and visits from famous movie characters and a real helicopter!

They purchased a postcard, addressed it to that woman, and got the opportunity to ring a bell or bang a gong and announce that woman's name in public! Said postcard was stamped and contained our QR code.

AAUW Reading has been busy. Our July book sale netted over \$100,000 which we share with our companion organization, Friends of the Berks County Public Libraries. Afterward, we jumped right into collecting and sorting for next summer's sale.



AAUW Reading was the sponsor of the Women's film block at the Reading Film Festival. A reception, called Sip, Savor, Screen, was held after the movies. The reception attracted over 40 participants and brought in four new memberships. Our members acted as servers and enjoyed mingling with guests. The reception brought recognition to the branch and through our purchase of



pastries from a local MBE bakery that had recently experienced a catastrophic fire

and was closed due to damages, we helped a local business.



During October, the Cultural Arts Interest Group presented a reading of the play "The Savannah Sipping Society". The actors did a full dress play but with scripts in hand. The play is about four women "of a certain age" who meet up by accident and join together determined to live a more exciting life. They learn that life is more interesting when you do things with friends. We invited friends and family and everyone had a good laugh. We've taken the moral of the story to heart!

## **AAUW Valley Forge**

Valley Forge Teacher Outreach

Are you interested in connecting with local teachers? Do you have some AAUW funds to donate? If you answer yes, here is an easy program that can be started and directed by one AAUW member. It supports local teachers who have needs in their classroom that are not covered by district funds, while giving you the opportunity to tell them about AAUW.

Teachers use the app DonorsChoose.org to request funding. Your AAUW Program Director, through the app, chooses a teacher in your area and supplies the funds they have requested. DonorsChoose.org buys the products and ships them to the teachers. You receive emails from the app as to when the products arrive. You can then send personal notes to the teachers (through their schools) introducing them to AAUW and inviting them to come to a meeting. So far, our branch has helped three local teachers.
